1. Proposed Charter amendment: Classified service eligibility register ([16-00549](#))

Setting a public hearing for an ordinance amending Article VIII, Section 8.5 (d) of the Minneapolis City Charter relating to Officers and Other Employees: Classified Service, by replacing the requirement that only the first three applicants can be certified for the eligibility register with a provision allowing the Council to establish modern procedures by ordinance. (*Postponed from the May 11, 2016, Committee of the Whole meeting*)
