Please see attached spreadsheet for proposal to keep East Harriet Farmstead Neighborhood (EHFN) South of 42nd Street in Ward 13 per reasons presented at hearing.

Neighborhood is lake focused.

Common interests with Lynnhurst, Fulton and Linden Hills Neighborhoods.

Businesses on both sides of 46th at Bryant Avenue have common interests.

East Harriet Farmstead Neighborhood Association has cultivated relationships with neighborhood groups and residents in Ward 13 over the past 10 years because of the shared priorities and issues facing us as a community of interest.

The best example of the strong ties around Lake Harriet is our signature winter event, Kitefest, that is sponsored by East Harriet, Lynnhurst and Linden Hills Neighborhoods along with the Park Board.

Numerous efforts have been made with neighborhood groups in Ward 8, these proposed partnerships have not come to fruition as the shared interests are not as strong.

Synopsis:

Option I. Move EHFN south of 42nd Street into Ward 13 from Ward 8
Move West Calhoun into Ward 7 from Ward 13.
Move West side of Ericsson Neighborhood west of Hiawatha Golf Course into Ward 8.

Option II. Move EHFN south of 42nd Street into Ward 13 from Ward 8
Move West side of Ericsson Neighborhood west of Hiawatha Golf Course into Ward 8

Both options keep each affected ward below 5% variation from the ideal.
