1. "No Trespassing" signs will be clearly posted on the exterior of the business. Grocery store staff will immediately ask people that are observed loitering in the immediate vicinity of the store to leave. If loitering persists, staff will call 9-1-1 and request police assistance to alleviate the loitering activity. The business agrees to cooperate fully in the prosecution of criminal activity.
2. All customers that appears to be under the age of 27 must provide proof of age through a photo identification card issued by a government authority for purchase of any alcohol or tobacco products. The business will supply either a calendar listing the date individuals turn 18 years of age or an identification card scanner. These items shall be used in every transaction involving the sale of alcohol and tobacco products.
3. The business agrees not to sell items that are commonly used by drug users and drug dealers. These items include, blunts, glass pipes, steel wool products, small zip bags, tobacco/postal scales, paper rolling devices, tobacco pipes, T-Shirts of any color and single use tobacco products, including rolling papers. The business will not supply matches to non-tobacco customers.
5. Persons working at the business shall wear name tags at all times.
6. The sale of goods considered to be formerly used items requires a second hand goods license. The business will not sell second hand goods without first obtaining the required license.
7. All license applications and renewals submitted by the business shall contain true and correct information concerning the ownership, conduct of the

business or other requested information. The business understands that the submission of false or fraudulent information will be subject to revocation of all business licenses.

8. The business will have operating hours as specified in the Minneapolis Zoning codes which states: Sunday through Thursday, 7a.m. to 10:00 p.m. and Friday and Saturday, 7:00 a.m. to 11:00 p.m.
9. The business shall remove all dead landscape plants, remove weeds and replace the wood chip mulch surrounding the plants by September 20, 2012
10. Security plan. Due to the recent incidents regarding safety and security on the 25 block of Chicago Avenue, the business agrees to meet with the Phillips neighborhood group, Children Hospital security staff and MPD 3rd Precinct to develop a store security plan. This plan shall be completed by October 31, 2012.

I have read the conditions listed above. I agree with the conditions and understand that failure on our part, or on the part of my company or employees to adhere to these conditions, may be cause for future adverse license action, including the suspension, revocation, or denial of the renewal of the L155 50811-CHICAGO FOOD DELI MARKET license. These conditions will be effective for the duration the license operates at these premises, unless otherwise amended by the City Council of Minneapolis.


