BUSINESS LICENSE OPERATING CONDITIONS


Re: L172 50011 GREENWAY LIQUOR

1. Khosa Beverage Inc. agrees to require ID from all customers, who appear under the age or appearance of 50 years old, to ensure no one under 21 is sold alcohol.
2. Khosa Beverage Inc. agrees that it will not offer for sale individual small bottles of liquor (50 ml or smaller).
3. Khosa Beverage Inc. agrees to prohibit employees from consuming alcohol on the premises.
4. Khosa Beverage, Inc. agrees to pick up all litter within 100 feet of the premises on a daily basis.
5. Khosa Beverage, Inc. agrees to not accept change in excess of Two Dollars and Fifty Cents (\$2.50) for any transaction.
6. Khosa Beverage, Inc. agrees to keep and maintain a Do Not Admit List to be kept near the service counter for immediate reference, as needed.

I have read the conditions listed above. I agree with the conditions and understand that failure on our part or on the part of my company or employees to adhere to these conditions, may be cause for future adverse license action, including the suspension, revocation, or denial of the renewal of the L172 50011 GREENWAY LIQUOR license. These conditions will be effective for the duration the license operates at these premises, unless otherwise amended by the City Council of Minneapolis.
