**BUSINESS LICENSE OPERATING CONDITIONS**

Re: L198 50140 FINE LINE MUSIC CAFE & EVENT CENTER  
for LIQ ON-SALE A W/SS SERIES 3000

1. During 18+ events, wristbands will be placed on those patrons of legal drinking age and different colored wristbands will be placed on all patrons under the age of 21. Additionally, black X's will be drawn on both hands of patrons under the age of 21. Patrons caught removing or altering their wristband or hand marks will be promptly removed from the establishment. Non-alcoholic drinks and those containing alcohol will be served in different types of cups to clearly distinguish between the two.
2. No alcohol shall be sold, served or be accessible to any patron when a 16+ event is held at the establishment.
3. Licensee shall not contract with private promoters in a manner in which they have control over door security. Contracts with promoters shall specify that the promoter must follow all applicable laws and regulations.
4. Licensee shall provide wristbands. No promoter will be allowed to provide wristbands.
5. During 18+ events, licensee shall provide attendants in all restrooms.
6. During 18+ events, no alcohol will be allowed in the restrooms.

7. During 18+ events, patrons under the age of 21 will not be allowed to re-enter the premises once they exit.
8. Licensee will require proper photo identification from all patrons to ensure no one under 21 is served alcohol.
9. Licensee will deny entry to any person under the age of 21 with any noticeable presence of alcohol in their system.
10. Licensee will deny entry to obviously intoxicated persons.
11. Licensee will utilize an electronic ID scanner to maintain a "do not admit" list, which will be made readily available upon request by Licenses & Consumer Services or the Police Department.
12. Licensee will enforce a dress code and no admittance will be given to any patron not in appropriate attire.
13. Licensee will maintain minimum food service during a substantial portion of operating hours.
14. Licensee will keep an accurate occupancy count immediately share those figures upon request by any official of the City of Minneapolis.
15. The licensee shall not permit employees to distribute handbills, flyers or business advertising cards to the public, or hire others to distribute handbills, flyers or business advertising cards, in or on any publicly owned street or sidewalk in the City of Minneapolis for more than four (4) events per year. On those days where material is distributed, staff will inspect the areas where the material was distributed and dispose of any material left behind.
16. All aspects of the Police Security Review Plan shall be complied with at all times.

**I have read the conditions listed above. I agree with the conditions and understand that failure on our part or on the part of my company or employees to adhere to these conditions, may be cause for future adverse license action, including the suspension, revocation, or denial of the renewal of the L198 50140 FINE LINE MUSIC CAFE & EVENT CENTER license. These conditions will be effective for the duration the license operates at these premises, unless otherwise amended by the City Council of Minneapolis.**
