On July 31, 2013, The owner of Al Madina Halal Market Inc approached the Business License Division with a request to reduce the \$1600 in administrative citations he received for failure to remove litter and debris within 100 feet as required by Minneapolis Code of Ordinances 259.125(a). Mr. Abdinasir Warfa was in the process of selling this business and wanted to resolve all outstanding issues with his business license. The following are the recommendations to resolve the outstanding administrative citations for Al-Madina Halal Market, Inc.

1. Administrative citation number 13-0987535, issued on July 27, 2013 for \$400 is due and payable by August 9, 2013.
2. Administrative citation number 13-993994 and 13-0985403 for \$400 and \$800 respectively shall be dismissed upon payment of the first citation and when the business license for the new operator is granted.

Mr. Abdinasir Warfa understands that the holding of a business or liquor license in the City of Minneapolis is both a privilege and a responsibility. A minimum standard shall be met in order to hold such a license. One minimum standard is that a license holder is responsible to ensure that its business operates in compliance with all applicable laws, ordinances, and regulations. It is understood and agreed that any violation of the above Recommendations shall constitute just and proper cause for the immediate imposition of any stayed penalties. It is further understood that compliance with the above Recommendations is a requirement for continuing to hold a license and that failure to comply with any of these conditions may result in additional adverse license action.

I have read and understand the above findings of fact, conclusions, and recommendations. I agree with their contents and I agree with the above noted Recommendations. I understand that the failure of my business to adhere to this agreement may be cause for further suspension, revocation, or denial of my license. I understand that this report must be accepted and approved by the Minneapolis City Council and Mayor.


