CERTIFICATION OF POST ELECTION DRAWING CITY OF MINNEAPOLIS GENERAL ELECTION NOVEMBER 5, 2013

In accordance to Minneapolis Municipal Ordinance 167.130, at canvass the chief election official must select by lot the offices and precincts to be reviewed and set the date, time and place for the post-election review. The post-election review must be conducted, in public, of a sample of ballots cast for at least one (1) single-seat ranked-choice voting election for city council, and one (1) multiple-seat ranked-choice voting election for either Park Board or Board of Estimate and Taxation.

Single Seat: The chief election official shall select, by lot, a total of two (2) precincts. Using the actual ballots cast in the two (2) precincts selected, the judges of the election shall conduct a hand count of ballots cast for the one (1) or two (2) offices of council member.

Multiple Seat: The chief election official shall select, by lot, a total of two (2) precincts. Using the actual ballots cast in the two (2) precincts selected, the judges of the election shall conduct a hand count of ballots cast for either the office of Park Board or the office of Board of Estimate and Taxation, also to be determined by lot.
