




Minneapolis and Metro Unemployment Rate





Percent of Employment and Unemployment by Race and Ethnicity




Per Capita Income


Building Permit Valuation (in millions)

Residents who rate the City of Minneapolis government "good" or "very good" on providing meaningful opportunities for citizens to give input on important issues







2012 Minneapolis General Election Voter Turnout as a Percent of Registered Voters By Precinct



2010 Minneapolis Population Distribution










Infant Mortality Rates by Race/Ethnicity (Number of Infant Deaths per 1,000 Live Births)






Percentage of Incoming Kindergartners Who Meet/Exceed Total Literacy Benchmark on the Beginning Kindergarten Assessment

Perceptions of Safety, by Community Planning District, 2012




Violent Crimes (Subset of Part I Crime)






Total Fire Calls by Type


Residents Who Agree Their Neighborhood Is Clean and Well-Maintained, by Community Planning District, 2012






Residential Building Conditions Index





Percentage of Solid Waste Stream Recycled by Weight







2012 Residents' Overall Satisfaction with City Services





Ending General Obligation Debt Balances (in millions)





General Fund Performance (in Millions)






How Would You Rate the Minneapolis City Government on Providing Value for Your Tax Dollars, Rating Very Good/Good





Female Representation in Workforce City FT Regular and Seasonal Employees




