Subject: **2014 Resurfacing Program – 5th St N, 8th Av N and 5th Av N and 58th St E and MN-62 Frontage Rd S,(Project No. 5258): Designation, Cost Estimate and Set Public Hearing**

Recommendation:

A. Pass a Resolution designating the proposed location and improvements be made for the 5th St N, 8th Av N and 5th Av N and 58th St E and MN-62 Frontage Rd S, Project No 5258 Street Resurfacing projects.

B. Adopt a Committee Report receiving the cost estimate of \$569,681 for the 5th St N, 8th Av N and 5th Av N and 58th St E and MN-62 Frontage Rd Street Resurfacing projects, the list of benefited properties, direct the City Engineer to prepare proposed Street Resurfacing Special Improvement Assessments against the list of benefited properties by applying the 2014 Uniform Assessment Rates and direct the City Clerk to give notice of a Project Approval and Assessment Public Hearing to be held on March 18, 2014 before the Transportation and Public Works Committee.

Supporting Information

Background

On February 15, 2008, the City Council approved the Asphalt Pavement Resurfacing Program. The purpose of this program is to extend the life of some city streets which are not scheduled for any preventative maintenance, renovation or reconstruction in the foreseeable future. This resurfacing program is targeting neighborhoods and MSA streets that are at a point in their life cycle where a new surface will extend the street's life and improve ride quality and neighborhood livability, and help slow the overall deterioration of our City street system.

The purpose of this letter is to designate the location, streets and improvements, and establish the special assessment improvement proceedings for street resurfacing.

- The location of the 5th St N street resurfacing project is from approximately 172 ft. southeasterly of 5th Av N (to the concrete bridge abutment) northwesterly to 10th Av N. Fifth St N at this location is MSA Route No. 218 and was last paved in 1930.
- The location of the 8th Av N street resurfacing project is from Oak Lake Av N to 5th St N. Eighth Av N at this location is a local city street and was last paved in 1957.
- The location of the 5th Av N street resurfacing project is from 5th St N approximately 194 feet to the northeast. Fifth Av N is being resurfaced in cooperation with the interchange project. The adjacent property owners are being assessed at the resurfacing rate.
- The location of the 58th St E street resurfacing project is from 42nd Av S to 46th Av S. Fifty-eighth St E at this location is a local city street and was last paved in 1967.
- The location of the MN-62 frontage road south resurfacing project is from 34th Av S to 46th Av S. The frontage road at this location is a local city street and was last paved in 1967.

As provided in Chapter 10, Section 8 of the City Charter, a list of parcels with owner's names, as nearly as can be readily ascertained, which would be benefited by and assessed for the 5th St N, 8th Av N and 5th Av N and 58th St E and MN-62 Frontage Road S Street Resurfacing Projects are on file with the City Engineer's Special Assessment Office.

Also submitted is a cost estimate of \$569,681 for this project.

Special Assessments

The street resurfacing special assessments would be determined by applying the 2014 Uniform Assessment Rates to the land area of benefited parcels located within the street influence zone along the improved streets. The approved 2014 resurfacing rates are as follows:

\$0.60/sq. ft. – Non-Residential

\$0.20/sq. ft. – Residential

Designating the improvement of certain existing streets in the 2014 Street Resurfacing Program at the locations described hereinafter.

Resolved by the City Council of the City of Minneapolis:

That the following existing streets within the City of Minneapolis are hereby designated to be improved, pursuant to the provisions of Chapter 10, Section 8 of the Minneapolis City Charter, by asphalt mill and overlay and including other street resurfacing related improvements as needed.

Fifth St N from approximately 172 ft. southeasterly of 5th Av N (to the concrete bridge abutment) northwesterly to 10th Av N.

Eighth Av N from Oak Lake Av N to 5th St N.

Fifth Av N from 5th St N approximately 194 feet northeast.

Fifty-eighth St E from 42nd Av S to 46th Av S.

MN-62 Frontage Road S from 34th Av S to 46th Av S.

T&PW – Your Committee, having received a cost estimate of \$569,681 for street resurfacing improvements and a list of benefited properties for certain locations in the 5th St N, 8th Av N and 5th Av N and 58th St E and MN-62 Frontage Road S Street Resurfacing Projects, Special Improvement of Existing Street No 5258, as designated by Resolution 2014R-_____ passed February 7, 2014, now recommends that the City Engineer be directed to prepare a proposed Street Resurfacing Special Improvement Assessment against the list of benefited properties by applying the 2014 Uniform Assessment Rates as per Resolution 2013R-509, passed November 12, 2013.

Your Committee further recommends that the City Clerk be directed to give notice of a public hearing to be held by the Transportation and Public Works Committee on March 18, 2014 in accordance with Chapter 10, Section 8 of the Minneapolis City Charter and Section 24.180 of the Minneapolis Code of Ordinances, to consider approving the resurfacing of the above designated street locations, and to consider the amount proposed to be assessed to each benefited property and the amount to be funded by the City.
