**PURPOSE OF APPLICATION:** To amend the current operating conditions that has been in effect since August 2012. Tibet-Kitchen is seeking to operate within the allowed hours of operation for this location which would be, 6:00a.m to 2:00a.m.

Prior to 2012 the previous ownership of Tibet-Kitchen & Bar had incidents that required police intervention. In 2012 new ownership took over Tibet-Kitchen and agreed to conditions on their license to address those issues. In 2012 Tibet-Kitchen & Bar were cited for numerous violations of their license conditions concerning happy hours and failure to have off duty police on the premises. The Tibet-Kitchen & Bar took significant measures to abate these violations. The License and Consumer Services Division Inspectors have conducted numerous evening inspections during 2013. There were no further violations of their business license operating conditions. Since 2013 under the new Tibet-Kitchen ownership, the number of police calls and the severity of the nature of the police calls have decreased. Minneapolis police 5<sup>th</sup> precinct has not reported any significant issues regarding this business and agreed that the conditions can be changed.

On November 21, 2013, the owners of Tibet Kitchen attended the Stevens Square Community meeting and presented the new proposal of the operating conditions. The Stevens Square Community Organization supports the proposed changes.

- 1) ~~The ownership of Tibet Kitchen Bar and Restaurant agrees to close the business at 12:00 midnight daily. All entertainment and music must cease at 11:45 p.m. All patrons must leave business by 12:30 a.m.~~
- 2) ~~The ownership of Tibet Kitchen Bar and Restaurant agrees to employ one off duty City of Minneapolis Police Officer with a marked squad car Thursday thru Sunday nights from 8:00 p.m. until closing time.~~
- 3) The ownership of Tibet Kitchen Bar and Restaurant agrees to furnish one security guard as defined in Minnesota Statute 326.32, subd 13, who will maintain security on-site from 7:00 p.m. 9:00p.m until one-half hour after closing ~~Monday through Wednesday nights, time daily.~~
- 4) The ownership of Tibet Kitchen Bar and Restaurant agrees to have security provide routine patrols every 30 minutes.
- 5) The ownership agrees to not allow entry or service of patrons who are intoxicated and trespass customers that are refused service due to over intoxication, creating a disturbance, or other disruptions.
- 6) Patrons who become disorderly will be escorted off of property.
- 7) Loitering will not be permitted inside the business or on the property outside.
- 8) The ownership of Tibet Kitchen Bar and Restaurant agrees to maintain their video surveillance system and have 30 days of recorded memory available from your surveillance system from all four cameras and if requested by Minneapolis Police or Business Licensing the recordings will be provided within eight hours of the request.

9) The ownership agrees to offer medical or emergency response to any patron or staff member who are injured that may require medical attention. If an injury is severe and a person is unable to care for themselves medical or emergency response will be made on their behalf. If a crime occurs security and staff will call Minneapolis Police and cooperate with responding officers.

10) Tibet Kitchen Bar and Restaurant will not promote or provide any "happy hours" or other alcoholic drink specials after 8:00 p.m. daily.

11) Tibet Kitchen Bar and Restaurant agrees to have a professional trained manager on-site during business hours.

I have read the conditions listed above. I agree with the conditions and understand that failure on our part or on the part of my company or employees to adhere to these conditions, may be cause for future adverse license action, including the suspension, revocation, or denial of the renewal of the L180 50144 TIBET KITCHEN BAR & RESTAURANT license. These conditions will be effective for the duration the license operates at these premises, unless otherwise amended by the City Council of Minneapolis.
