HISTORY OF LOCATION

The Walker Art Center has been a licensed establishment for many years. The applicant is the Walker Art Center's authorized concession provider and holds the On Sale Liquor license for this location. The Zoning, off-street parking, and the 7 acre requirements do not need to be met for this application as the City of Minneapolis may issue a license to the Walker Art Center's concessionaire or operator not withstanding limitations of law, or local ordinance or charter provisions under State Statue 340A.404.

APPLICANT

The applicant is D'Amico Catering, LLC, a Minnesota company registered with the State of Minnesota Secretary of State's office since 3/7/2003 (File No. 39233-LLC) and has held an On Sale Liquor Class B license at this location, since 3/22/2011. The following are listed as company officers:

POLICE REVIEW

Police Licensing and this inspector have reviewed the expenses and source of funds reported in this application. The applicant has passed the criminal background check.

PREMISES

The newly expanded outdoor area which will be part of the licensed premises will consist of approximately 30,000 square feet and is located to the north of the building along Vineland Place. The seating in the outdoor area will be temporary and will vary according to needs of events held in the area. No permanent seating area exists.

BUSINESS PLAN/OPERATIONS

The applicant will operate a small concession stand in the outdoor area. The area will be monitored and staffed at all times by employees and is fenced in. The area provides mini-golf through the Walker Art Center. At the present time, the applicant does not intend to offer any form of live entertainment in the outdoor area or have outside speakers. Health Department approvals have been obtained for the menu and use of the concession stand.

RECOMMENDATION

Business Licenses recommends approving this application for a permanent expansion of premises for an outdoor area.


