Subject: Land Sale Public Hearing
Vacant Housing

Recommendation: Approve the sale of 52 18th Avenue NE to Tony Sorenson for \$15,300, subject to the following conditions; 1) land sale closing must occur on or before 90 days from the date this Resolution is approved by the City, and 2) payment of holding costs of \$300.00 per month if the land sale closing does not occur on or before the closing deadline. The sale conditions may be waived or amended with approval of the Community Planning & Economic Development (CPED) Director.

Previous Directives: On March 30, 2012, City Council authorized staff to begin marketing and selling properties acquired under the Land Bank strategy of the City's Neighborhood Stabilization Program (NSP 1, 2 and 3) using the City's normal disposition policies and procedures for development parcels. CPED acquired 52 18th Avenue NE on July 28, 2010.

PROPOSED DEVELOPMENT:

A two-story single family home with four bedrooms and two and one-half baths with approximately 2,300 square feet of finished living space. The home will have an approximate 500 square feet in the basement and the development will have a two-car detached garage.

The lot size is 60' x 100' = 6,000 total square feet.

LAND DISPOSITION POLICY:

This property is a buildable lot as defined by City policy and is being sold for development.

FINANCING*:

Financing is being provided by David R. Bursch.

*Subject to application and underwriting requirements.

OFFERING PROCEDURE:

Public Advertisement. The sales price of this property does reflect the full re-use value.

COMMENTS:

On July 28, 2010, CPED acquired a single home from Federal Home Loan Mortgage Corporation for \$15,000 under the Neighborhood Stabilization Program (NSP), Land Banking activity. The City of Minneapolis subsequently demolished the structure and the vacant land was marketed for housing development. All land sale proceeds, equal to the fair market value, will be returned to the NSP Program to cover ongoing program costs. The four-bedroom single home is being developed for the purchaser's homestead.

Authorizing sale of land Vacant Housing Disposition Parcel No VH-554.

Whereas, the City of Minneapolis, hereinafter known as the City, has received an offer to purchase and develop Disposition Parcel VH-554, in the Sheridan neighborhood, from Tony Sorenson, hereinafter known as the Redeveloper, the Parcel VH-554, being the following described land situated in the City of Minneapolis, County of Hennepin, State of Minnesota to wit:

LEGAL DESCRIPTION

VH-554; 52 18th Avenue NE

West ½ of Lot 7 and West ½ of Lot 8, Block 5, Orth and Hectman's Addition to St. Anthony.

Whereas, the Redeveloper has offered to pay the sum of \$15,300, for Parcel VH-554 to the City for the land, and the Redeveloper's proposal is in accordance with the applicable Redevelopment Plan and/or Program; and

Whereas, the Redeveloper has submitted to the City a statement of financial responsibility and qualifications; and

Whereas, the City has had the re-use value reviewed by an appraisal expert, stating that the re-use value opinion is consistent with the accepted methods in aiding the City in determining a re-use value for the Parcel; and

Whereas, pursuant to due notice thereof published in *Finance and Commerce* on May 23, 2014, a public hearing on the proposed sale was duly held on June 3, 2014, at the regularly scheduled Community Development and Regulatory Services Committee meeting of the City Council, at the Minneapolis City Hall, 350 South 5th Street, Room 317, at 1:30 p.m., in the City of Minneapolis, County of Hennepin, State of Minnesota;

Now, Therefore, Be It Resolved by The City Council of The City of Minneapolis:

That the re-use value for uses in accordance with the Vacant Housing plan, as amended, is hereby estimated to be the sum of \$15,300 for Parcel VH-554.

Be It Further Resolved that the acceptance of the offer and proposal is hereby determined to be in accordance with the City's approved disposition policy and it is further determined that the Redeveloper possesses the qualifications and financial resources necessary to acquire and develop the parcel in accordance with the Redevelopment Plan and/or Program.

Be It Further Resolved that the proposal be and the same is hereby accepted, subject to the execution of a contract for the sale of land and further subject to the following conditions; 1) land sale closing must occur on or before 90 days from the date this Resolution is approved by the City and 2) payment of holding costs of \$300.00 per month if the land sale closing does not occur on or before the closing deadline.


Be It Further Resolved that the sale conditions described above may be waived or amended with the approval of the CPED Director.

Be It Further Resolved that upon publication of this Resolution, the Finance Officer or other appropriate official of the City be and the same is hereby authorized to execute and deliver the contract to the Redeveloper; provided, however, that this Resolution does not constitute such a contract and no such contract shall be created until executed by the Finance Officer or other appropriate official of the City.

Be It Further Resolved that the Finance Officer or other appropriate official of the City is hereby authorized to execute and deliver a conveyance of the land to the Redeveloper in accordance with the provisions of the executed contract and upon payment to the City for the purchase price thereof; provided, however, that this Resolution does not constitute such a conveyance and no such conveyance shall be created until executed and delivered by the Finance Officer or other appropriate City official of the City.
