BUSINESS LICENSE OPERATING CONDITIONS

Re: L181 50007 LAWLESS DISTILLING COMPANY
for LIQ ON-SALE C-2 SERIES 1000

1. The licensee will have interior business hours Wednesday through Thursday 4:00 p.m. to 11:00 p.m., Friday 4:00 p.m. to 12:00 a.m., and Saturday 12:00 p.m. to 12:00 a.m. Should the licensee wish to add additional hours, a new business plan shall be submitted to Business Licensing for review.
2. The licensee shall post visible signage at the premise that states: "Out of consideration to our neighbors, please keep noise to a minimum."
3. The licensee shall not use outdoor speakers.
4. The licensee shall meet with a representative of the City of Minneapolis Environmental Management Division to undergo sound/noise mitigation evaluation to review strategies to determine and minimize unwanted sound emanating from the indoor area from live music events.
5. The licensee shall collect all litter within 100 feet of the exterior of the building frequently on a daily basis.
6. The licensee shall take reasonable measures to keep the rear door closed to minimize noise being exposed to the alley.
7. The licensee shall post a sign and/or a portable fence/traffic cones to prevent vehicles from existing their rear parking area into the alley.
8. The licensee shall post an employee in the parking lot immediately after closing time to remind patrons to keep their voices down to prevent a neighborhood disturbance.

I have read the conditions listed above. I agree with the conditions and understand that failure on our part or on the part of my company or employees to adhere to these

conditions, may be cause for future adverse license action, including the suspension, revocation, or denial of the renewal of the L181 50007 LAWLESS DISTILLING COMPANY license. These conditions will be effective for the duration the license operates at these premises, unless otherwise amended by the City Council of Minneapolis.
