POLICE REVIEW

Minneapolis Police Licenses and the 3rd Precinct have reviewed the application. They found no criminal or financial issues to prevent the issuance of this license.

PREMISES

The restaurant is on one level for a total of 1300 square feet of restaurant and bar space, as well as another 1300 square feet for the kitchen, preparation areas, coolers, storage, and restrooms. There are no undefined spaces.

The main floor has seating for 54 people. The men’s and women’s restrooms are both located on this floor. The kitchen is also on the main floor.

BUSINESS/PLAN/OPERATIONS

Menu items will mainly be Spanish dishes, Lomo Saltado, NY steak, pasta Italiana, pasta Romana, and Ensalada vegetarian. The hours of operation will be 11:00 A.M to 1:00 A.M seven days a week.

The applicant is requiring all servers to attend alcohol server training. Their business plan indicates an alcohol policy that requires all patrons will be carded.

The license holder is requesting a Class E entertainment license which permits the use of radio, television, prerecorded music, karaoke, and jukebox with limited non-amplified sound in the premises

PUBLIC HEARING SUMMARY

There is no public hearing required for this application because the license type and class of entertainment are not increasing from what was previously allowed at this location.

RECOMMENDATION

The Licenses and Consumer Services Division recommends approving this application for an On-Sale Wine/Strong Beer Class E.
