BUSINESS LICENSE OPERATING CONDITIONS

Re: L210-50217 THE VENUE MINNEAPOLIS
for LIQ ON-SALE B W/SS SERIES 4000

1. Patrons under the age of 18 must be accompanied by a parent or guardian.
2. All aspects of the Police Security Review Plan shall be complied with at all times.
3. The licensee shall collect all litter within 100 feet of the exterior of the licensed premises on a daily basis.
4. The licensee shall at all times keep an accurate occupancy count and immediately share such figures upon the request to any official of the City of Minneapolis.
5. The licensee shall schedule and maintain adequate security beyond closing time to assist in effective dispersal of crowds from the sidewalk in front of the business.
6. The licensee shall not permit employees to distribute handbills, flyers or business advertising cards to the public, or hire others to distribute handbills, flyers or business advertising cards, in or on any publicly owned street or sidewalk in the City of Minneapolis.
7. The licensee shall send a representative to attend at least 50% of the Liquor Industry and the City (LINC) meetings.
8. The licensee shall make a good faith effort to trespass those patrons causing significant disturbances.
9. The licensee shall employ a manager, an assistant manager, or supervisory-level employee at all times the business is open to the public.
10. The licensee shall perform criminal background checks on any new employee and maintain a copy of the employee's identification and background check on location.

The following conditions were added on May 16, 2016:

11. When holding an event that is open to the public, or advertised as such in any media, patrons shall be at least twenty-one (21) years of age to be in attendance after 9:00PM.
12. The licensee shall only allow any Sunday sales when they are in compliance with the definition of a restaurant per Minneapolis Code of Ordinances 360.10.
13. The licensee shall ensure that they are always in control of their entrance with employed staff.
14. The licensee shall not allow any use of the lobby at 311 1st Avenue North for their business. The door that connects the lobby of 311 1st Avenue North to the licensed premises at 315 1st Avenue North shall not be used for any patrons to pass between the two areas.
15. All promotional materials for this business shall be reviewed by the owners or management for approval before they are posted in any media for advertising an event.
16. These conditions replace any previously approved license operating conditions for this business.

I have read and understand the conditions listed above. I agree with the conditions and understand that failure on our part or on the part of my company or employees to adhere to these conditions, may be cause for future adverse license action, including the suspension, revocation, or denial of the renewal of the L210-50217 THE VENUE MINNEAPOLIS license. These conditions will be effective for the duration the license operates at these premises, unless otherwise amended by the City Council of Minneapolis.
