

# OFFICIAL PROCEEDINGS MINNEAPOLIS CANVASSING BOARD

## REGULAR MEETING OF NOVEMBER 12, 2013

Present - Council Members Schiff, Lilligren, Tuthill, Quincy, Glidden, Goodman, Hodges, President Johnson.

Absent – Council Members Hofstede, Colvin Roy, Samuels, Gordon, Reich.

The regular municipal election for the City of Minneapolis was conducted on November 5, 2013, with final tabulation of all races and questions on that ballot having been concluded on November 8, 2013. In total, 80,099 ballots were cast, representing a 33.38 percent voter turnout. Unofficial results were posted in the City Hall Rotunda Information Center and to the City's elections website for public access. A full report, including a statistical analysis, has been compiled and provided to the Canvassing Board. A copy of this material will also be published to the City's website.

Minnesota Statutes designate the City Council as the Canvassing Board for municipal elections. By convening the Canvassing Board on the seventh day following the general election, the City of Minneapolis is within the statutory timeframe to complete the canvassing of returns.

Johnson moved approval of the following Order which:

1. Certifies the official results of the 2013 Municipal Election.
2. Declares the official winners in each race on the ballot, indicating the names of each person receiving votes and the number of votes received by each office voted upon.
3. Declares the official results for each question on the ballot, indicating the number of votes for and against each question voted upon.
4. Directs the City Clerk to submit a certified copy of the official results of the 2013 Municipal Election to the Hennepin County Auditor and to file and preserve the original returns and all election records for the 2013 Municipal Election in accordance with Minnesota Election Law. Seconded.

Adopted.

Absent – Hofstede, Colvin Roy, Samuels, Gordon, Reich.

A Post-Election Review, in accordance with the requirements of Chapter 167 of the Minneapolis Code of Ordinances, was drawn by lot during the canvass of the November 5, 2013 election results, and will be conducted as follows:

November 21, 2013, and November 22, 2013 (if needed) at 9:00 a.m. at the Elections Warehouse, 732A Harding St NE, Minneapolis MN 55413.

The precincts to be hand-counted are as follows:

City Council Ward 6, Precinct 3 and Ward 10, Precinct 2.

Board of Estimate & Taxation, Ward 9, Precinct 1 and Ward 2, Precinct 8.

By unanimous consent, the meeting was adjourned at 9:43 a.m.
