**CD&RS** – Your Committee, to whom was referred an ordinance amending Title 13, Chapter 295 of the Minneapolis Code of Ordinances relating to Licenses and Business Regulations: Groceterias and Portable Stores, to allow a larger selection of staple foods and expand the locations available for mobile foods stores, now recommends that Ordinance 2014-Or-022 be given its second reading for amendment and passage.

**ORDINANCE 2014-Or-022**

**Amending Title 13, Chapter 295 of the Minneapolis Code of Ordinances relating to Licenses and Business Regulations: Groceterias and Portable Stores.**

The City Council of the City of Minneapolis do ordain as follows:

Section 1: That the title of Chapter 295 of the Minneapolis Code of Ordinances be amended to read as follows:

**CHAPTER 295. ~~GROCETERIAS AND PORTABLE~~ MOBILE FOOD STORES**

Section 2: That Section 295.10 of the above-entitled ordinance be amended to read as follows:

**295.10. License required.** No person shall maintain, use, conduct or operate within the city any ~~groceteria or any portable~~ mobile food store of any kind for transportation from place to place, and sale of, any groceries, meats, provisions and miscellaneous goods, wares and merchandise of any kind without first having procured a license to do so from the city council.

Section 3: That Section 295.20 of the above-entitled ordinance be amended to read as follows:

**295.20. Application for license.** Any person desiring a license under this chapter shall file with the licensing official a written application to the city council for such license, stating in such application the full name and address of the owner or proprietor of the ~~groceteria or portable~~ mobile food store to be conducted and operated by the applicant, and for which a license is desired, ~~and the locations within the city where the applicant proposes to conduct and operate the same,~~ and the kind of groceries, meats, provisions and miscellaneous goods, wares and merchandise the applicant desires to transport and sell under such license.

Section 4: That Chapter 295.30 of the above-entitled ordinance be amended to read as follows:

**295.30. Place of sale limited.** No sales of food or other products shall be made from any mobile ~~grocery~~food store upon the city streets, alleys or public ways, and sales of ~~prepackaged food products~~ from such ~~groceries~~mobile food stores shall be limited to ~~designated senior citizens' high rise apartments that do not have a licensed grocery meat market operation on the premises~~ parking lots accessory to commercial, industrial, or high-density residential properties, with the written permission of the property owner or manager. No mobile food store may operate within one hundred (100) feet of a licensed grocery store or operating farmers market, except with the express permission of that grocery store or farmers market. Mobile food stores shall not block fire lanes or access for persons with disabilities, and shall operate in a manner that avoids pedestrian and motor vehicle conflicts.

Section 5: That Section 295.40 of the above-entitled ordinance be amended to read as follows:

**295.40. Foods permitted to be sold.** (a) The licensee shall sell only prepackaged staple foods as defined by section 203.10 of this Code and fresh produce approved by the commissioner of health. As used in this section:

(a 1) "Commissioner of health" shall mean the commissioner of health of the city and authorized representatives.

(b 2) "Prepackaged foods" shall mean clean, unadulterated, wholesome food packaged in a substantial, clean container or wrapper.

(3) "Fresh produce" shall mean raw, uncut fruits and vegetables.

All perishable and readily perishable foods, as defined by section 186.50 of this Code shall comply with this section.

Section 6: That Chapter 295 of the Minneapolis Code of Ordinances be amended by adding thereto a new Section 295.45 to read as follows:

**295.45. Foods required to be sold.** All mobile food stores licensed under this chapter must offer for sale at least fifty (50) items total of fresh fruits and vegetables in at least seven (7) varieties, and with no more than 50% of the total selection being from a single variety.

Section 7: That Section 295.50 of the above-entitled ordinance be amended to read as follows:

**295.50. Protection from contamination and spoilage.** All food while being stored or transported, shall be protected against contamination by dirt, dust, grease, flies, rodents and other vermin, and all perishable foods shall be kept at temperatures sufficient to protect against spoilage. The temperature of readily perishable food during storage and transportation shall be forty (40) degrees Fahrenheit or lower and frozen foods in storage and transportation shall be kept at or below zero (0) degrees Fahrenheit. Food may be sold inside the vehicle or from an area no more than thirty (30) feet from the vehicle and no larger than one hundred (100) square feet in size.

Section 8: That Section 295.60 of the above-entitled ordinance be amended to read as follows:

**295.60. Sanitation.** All equipment and utensils installed or used shall comply with or be equal to the requirements of the National Sanitation Foundation standards as required by chapter 188 of this Code. The floors, walls, ceiling and storage shelves of ~~groceries~~ mobile food stores shall be of such construction so as to withstand repeated washings, and shall be kept clean at all times. All employees shall maintain a high degree of personal cleanliness and conform to hygienic practices while in service in mobile stores.

Section 9: That Section 295.70 of the above-entitled ordinance be amended to read as follows:

**295.70. Prevention of litter, noise; compliance with consumer protection.** When leaving a sales area, the licensee or operator of a ~~groceries~~ mobile food store shall pick up all litter resulting from the business sales, and shall deposit such litter in an approved, covered metal garbage receptacle located on the mobile ~~groceries~~ food store. The licensee shall fully comply with all applicable city ordinances regarding noise control, and the mobile ~~groceries~~ food store shall comply with the provisions of chapter 152 of this Code, relating to the sale of commodities. No mobile food store shall use or maintain any outside sound amplifying equipment, televisions or similar visual entertainment devices, lights, or noisemakers, such as bells, horns, or whistles.

Section 10: That Chapter 295 of the Minneapolis Code of Ordinances be amended by adding thereto a new Section 295.75 to read as follows:

**295.75. Hours of operation.** Hours of operation shall be limited to the hours between 8:00 a.m. and 9:00 p.m.

Section 11: That Section 295.90 of the above-entitled ordinance be amended to read as follows:

**295.90. Insurance.** The licensee shall provide evidence of liability insurance in the amount of ~~one hundred thousand dollars (\$100,000.00) for individual or three hundred thousand dollars (\$300,000.00) for any single incident and property damage coverage in the amount of five thousand dollars (\$5,000.00)~~ five hundred thousand dollars (\$500,000.00). Certificate of insurance shall be filed with the licensing official prior to issuance of a license.

Section 12: That Section 295.100 of the above-entitled ordinance be amended to read as follows:

**295.100. When licenses expire and fees.** The annual license fee for each mobile ~~groceries~~ food store under this chapter shall be as established in Appendix J, License Fee Schedule. The fee required shall be in addition to any fees required by ~~Chapter 188~~ for licenses otherwise required by the Code of Ordinances. Licenses issued under this chapter shall expire on April first of each year.

Section 13: That Chapter 295.110 of the above-entitled ordinance be amended to read as follows:

**295.110. ~~Locations, schedules to be filed; m~~Marking and inspection of vehicles.** The list of locations to be served and the schedule of service to each location shall be kept currently revised and on file with the department, and each vehicle used as a ~~groceries~~ mobile food store shall have affixed thereto, in a conspicuous place so as to be legible at all times, the name, address, and telephone number of the owner or licensee, and a food vehicle license number and decal furnished by the licensing official. Each vehicle used as a mobile food store shall be in a good state of repair and appearance, shall at all times be in compliance with commercial vehicle safety and inspection requirements, and shall not be stored in residential districts or on-street.

Section 14: That Chapter 295 of the Minneapolis Code of Ordinances be amended by adding thereto a new Section 295.115 to read as follows:

**295.115. Restricted products.** Mobile food stores may not sell beverage alcohol, tobacco, or tobacco related products. Retail items that are not designed for human consumption shall comprise no more than 10% of the space in the mobile grocery store.

Section 15: That Section 295.120 of the above-entitled ordinance be amended to read as follows:

**295.120. Violations.** Should the conditions of licensing under this chapter or any other applicable ordinance of the city cease to be met, such violations shall be cause for adverse license actions including the issuance of an ordinance violation tag citations, and possible cause for the imposition of reasonable conditions or restrictions upon the license, a license suspension, denial of renewal, or license revocation.

Whereas, a Rental License Conditions meeting was held on April 23, 2014, regarding the Rental Dwelling License for the above-mentioned property and the licensee did appear at the hearing; and

Whereas, pursuant to negotiations between the City of Minneapolis and the licensee, the parties agreed to a Stipulated Agreement in order to allow the licensee to retain the Rental Dwelling License for said property;

Now, Therefore, Be It Resolved by The City Council of The City of Minneapolis:

That Quang Tuan Tran be allowed to retain the Rental Dwelling License for the property located at 3741 1st Ave S, Minneapolis, subject to the following Stipulated Agreement and Conditions, as on file in the office of the City Clerk:

1. The Respondent, Quang Tuan Tran hereby agrees to keep the rental license current on the property located at 3741 1st Avenue South.
2. The Respondent, Quang Tuan Tran hereby agrees to submit a successful management plan to the Minneapolis Police Department c/o Luther Krueger, Crime Prevention Analyst, 350 5th St S., Room 100, Minneapolis, MN 55415 within 30 days of signing the Stipulated Agreement.
3. The Respondent, Quang Tuan Tran hereby agrees to attend a Rental Property Owner's Workshop within three months of signing the Stipulated Agreement.
4. The Respondent, Quang Tuan Tran hereby agrees to allow a full rental license inspection to be conducted at the above mentioned property on or before 5-15-2014.
5. The Respondent, Quang Tuan Tran hereby agrees to abate the order RFS #13-0991123 – Repair the chimney in a professional manner, on or before 6-1-2014. If owner cannot repair chimney by 6-1-2014, he must submit a certified safety check by a mechanical contractor. Then the order will be extended for 15 days.
6. The City of Minneapolis agrees to allow the pending assessments related to administrative citations - RFS #13-0991123 in the amount of \$3300 to roll onto the Respondent Quang Tuan Tran's, property taxes for Levy year 2014.
7. The Respondent, Quang Tuan Tran hereby agrees to comply with any written orders issued by Fire/Housing Inspection Services in a timely manner such that an administrative enforcement method is not required to obtain compliance.

**Amending Title 10, Chapter 204 of the Minneapolis Code of Ordinances relating to Food Code: Environmental Preservation: Environmentally Acceptable Packaging.**

The City Council of the City of Minneapolis do ordain as follows:

Section 1. That Section 204.10 of the above-entitled ordinance be amended to read as follows:

**204.10. Legislative purpose.** The city council finds that discarded packaging from foods and beverages prepared for immediate consumption constitutes a significant and growing portion of the waste in Minneapolis' waste stream. Regulation of food and beverage packaging, therefore, is a necessary part of any effort to encourage a recyclable and compostable waste stream, thereby reducing the disposal of solid waste and the economic and environmental costs of waste management for the citizens of Minneapolis and others working or doing business in Minneapolis.

The council further finds that plastic packaging is rapidly replacing other packaging material, and that ~~most~~ some plastic packaging used for foods and beverages is ~~nondegradable nonreusable, nonreturnable, and nonrecyclable and noncompostable.~~

The council also finds that the two (2) main processes used to dispose of discarded ~~nondegradable nonreusable, nonreturnable, and nonrecyclable and noncompostable~~ plastic food and beverage packaging are land filling and incineration, both of which should be minimized for environmental reasons.

The council therefore finds that the minimization of ~~nondegradable nonreusable, nonreturnable, and nonrecyclable and noncompostable~~ food and beverage packaging originating at retail food establishments and at events providing food and/or beverages within the city of Minneapolis is necessary and desirable in order to minimize ~~reduce~~ the city's waste stream, so as to reduce the volume of landfilled waste, to minimize toxic by-products of incineration ~~to make the waste stream less damaging to the environment,~~ and to make our city and neighboring communities more environmentally sound places to live.

Section 2. That Section 204.20 of the above-entitled ordinance be amended to read as follows:

**204.20. Definitions.** As used in this chapter, the following terms and phrases shall have the meanings as defined in this section:

(a) *Packaging* shall mean and include food or beverage cans, ~~glass bottles, or plastic bottles or~~ containers used to package food and beverage products for distribution including glasses, cups, plates, serving trays, and to-go containers; but shall specifically exclude foods pre-packaged by the manufacturer, producer or distributor; plastic knives, forks and spoons sold or intended for use as utensils; and plastic films less than ten (10) mils in thickness.

(b) *Environmentally acceptable packaging* shall mean and include any of the following:

(1) *Reusable and Returnable packaging:* Food or beverage containers or packages, such as, but not limited to, ~~soft drink bottles~~ water bottles, growlers, and milk containers and bulk product packaging that are capable of being refilled at a retail location or returned to the distributor, such as, but not limited to, dairies and soft drink bottlers, for reuse at least once as a container for the same food or beverage;

(2) *Recyclable packaging:* Packaging that is separable from solid waste by the generator or during collection for the purpose of recycling including glass bottles, aluminum cans and plastic food and beverage packaging that have robust recycling markets. For the purposes of this chapter, environmentally preferable plastic packaging includes the following plastic types:

a. Polyethylene Terephthalate (#1 PET or PETE);

b. High Density Polyethylene (#2 HDPE); and

c. Polypropylene (#5 PP).

(3) *Compostable packaging:* Packaging that is separable from solid waste by the generator or during collection for the purpose of composting. Compostable packaging must be made of paper, certified compostable plastics that meet ASTM D6400 or ASTM D6868 for compostability or other cellulose-based packaging capable of being decomposed through composting or anaerobic digestion.

(c) *Food establishment*, as used in this chapter, means a "food establishment" as defined in section ~~488.10~~ 186.50 of the Minneapolis Code of Ordinances.

Section 3. That Section 204.30 of the above-entitled ordinance be amended to read as follows:

**204.30. Prohibitions and duties.** (a) No person owning, operating or conducting a food establishment or any person or organization providing free food or beverage products within the city of Minneapolis pursuant to a permit or license, or in a manner which would require a permit or license, shall do or allow to be done any of the following within the city: Sell or convey at retail or possess with the intent to sell or convey at retail any food or beverage intended for immediate consumption contained, at any time at or before the time or point of sale, in packaging which is not environmentally acceptable packaging. The presence on the premises of the food establishment of packaging which is not environmentally acceptable packaging shall constitute a rebuttable presumption of intent to sell or convey at retail, or to provide to retail customers packaging which is not environmentally acceptable packaging; provided, however, that this subparagraph shall not apply to manufacturers, brokers or warehouse operators, who conduct or transact no retail food or beverage business.

(b) Packaging used to contain food or beverages intended for immediate consumption consumed at the point of sale shall be considered environmentally acceptable packaging only when the food establishment provides consumers with an opportunity to recycle and/or appropriately manage compostable plastics and utilizes a qualified recycling and/or organics management system. ~~A qualified recycling system shall have the following elements:~~

(1) A qualified recycling system shall have the following elements:

a.(1) A clear and verifiable process for separating recyclable packaging from discarded solid waste; and

b.(2) Collection and delivery of recyclable packaging to a recycling facility for processing in the same or at least similar manner as recyclable packaging collected in a municipally approved recycling program.

(2) A qualified organics management system shall have the following elements:

a. A clear and verifiable process for separating organic materials from discarded solid waste; and

b. Collection and delivery of organic materials to a food to people, food to animals, organics composting or anaerobic digestion facility in the same manner or at least similar manner as organic materials collected in a municipally approved organics management program.

Section 4. That Section 204.40 of the above-entitled ordinance be amended to read as follows:

**204.40. Enforcement.** The environmental health division of the health department shall have the duty and the authority to enforce the provisions of this chapter. The license official shall also have authority to enforce the provisions of this chapter.

Section 5. That Section 204.50 of the above-entitled ordinance be amended to read as follows:

**204.50. Rules and regulations.** The environmental health division may, upon notice and hearing, promulgate such rules and regulations as may be necessary to carry out the purposes of this chapter and protect the health of the public, including the development of exemptions under section 204.70 for packaging for which there is no reasonable commercially available alternative. In promulgating such rules, the ~~director~~ division shall consider the legislative purposes provided in section 204.10 of this chapter and shall consult with the operators of affected food establishments.

Section 6. That Section 204.60 of the above-entitled ordinance be and is hereby repealed:

~~**204.60. Advisory committee on environmentally acceptable packaging.** (a) The city council shall, by resolution, establish an advisory committee on environmentally acceptable packaging. The resolution shall provide for the membership, manner of appointment, the committee's charge and its duration. The membership shall be drawn from affected governmental units, business and industry, trade associations, general business organizations, consumer groups, environmental groups and others as determined in the resolution. The advisory committee shall include a member designated by the Hennepin County Board of Commissioners from outside the City of Minneapolis and a member designated by the Association of Metropolitan Municipalities. The charge of the committee shall include the following:~~

~~(b) Advising the environmental health division on implementation issues.~~

**204.80.
