**ELECTIONS** - Your Committee reports that, pursuant to instructions, we canvassed the official returns submitted by the Judges of Election of the various election districts of the votes cast for City Officers at the Primary Election held in the City of Minneapolis on Tuesday, September 13, 2005, and herewith submit the results of our canvas, in accordance with the accompanying tables. (Petn 270663)

The total number of registered voters was 228,610 (not including those persons who registered on election day). The total number of voters who registered on election day was 2,219. The total number of votes cast at the primary election was 33,558 or 15% (based on the number of pre-registered voters).
