Subject: **2010 Resurfacing Program – Broadway St NE (Stinson Blvd to Industrial Blvd) Street Resurfacing Project No 5197: Designation, Cost Estimate and Set Public Hearing**

Recommendation:

1. Passage of a resolution designating the location and improvements proposed to be made in the Broadway St NE (Stinson Blvd to Industrial Blvd) Area Project No 5197 Street Resurfacing project.
2. Adoption of a Committee Report receiving the cost estimate of \$612,840 for the Broadway St NE Area Street Resurfacing project, the list of benefited properties, directing the City Engineer to prepare proposed Street Resurfacing Special Improvement Assessments against the list of benefited properties by applying the 2010 Uniform Assessment Rates and directing the City Clerk to give notice of Project Approval and Assessment Public Hearings to be held on June 22, 2010 before the Transportation and Public Works Committee.

Background/Supporting Information:

On February 15, 2008, the City Council approved the Asphalt Pavement Resurfacing Program. The purpose of this program is to extend the life of some city streets which are not scheduled for any preventative maintenance, renovation or reconstruction in the foreseeable future. This resurfacing program is targeting neighborhoods and MSA streets that are at a point in their life cycle where a new surface will extend the street's life and improve ride quality and neighborhood livability, and help slow the overall deterioration of our City street system.

The purpose of this letter is to designate the location, streets and improvements, and establish the special assessment improvement proceedings for street resurfacing.

The location of the street resurfacing project is Broadway St NE from Stinson Boulevard to Industrial Boulevard. Broadway St NE at this location is MSA route 333.

As provided in Chapter 10, Section 8 of the City Charter, submitted herewith is a list of parcels with owner's names, as nearly as can be readily ascertained, which would be benefited by and assessed for the Broadway St NE Street Resurfacing Project.

Also submitted is a cost estimate of \$612,840 for the Broadway St NE Street Resurfacing Project.

The street resurfacing special assessments would be determined by applying the 2010 Uniform Assessment Rates to the land area of benefited parcels located within the street influence zone along the improved streets. The 2010 resurfacing assessment rates are:

\$0.49 /sq ft – Non-Residential

\$0.19/sq ft – Residential

**BROADWAY ST NE (STINSON BLVD TO INDUSTRIAL BLVD) STREET RESURFACING PROJECT
SPECIAL IMPROVEMENT OF EXISTING STREET NO 5197**

Designating the improvement of certain existing streets in the 2010 Street Resurfacing Program at the locations described hereinafter.

Resolved by the City Council of the City of Minneapolis:

That the following existing streets within the City of Minneapolis are hereby designated to be improved, pursuant to the provisions of Chapter 10, Section 8 of the Minneapolis City Charter, by asphalt mill and overlay and including other street resurfacing related improvements as needed.

Broadway St NE from Stinson Boulevard to Industrial Boulevard.

T&PW – Your committee, having received cost estimates of \$612,840 for street resurfacing improvements and a list of benefited properties for certain locations in the Broadway St NE (Stinson Blvd to Industrial Blvd) Street Resurfacing Project, Special Improvement of Existing Street No. 5197, as designated by Resolution 2010R-_____ passed May 28, 2010, now recommends that the City Engineer be directed to prepare a proposed Street Resurfacing Special Improvement Assessment against the list of benefited properties by applying the 2010 Uniform Assessment Rates as per Resolution 2010R-038, passed January 29, 2010.

Your Committee further recommends that the City Clerk be directed to give notice of a public hearing to be held by the Transportation and Public Works Committee on June 22, 2010 in accordance with Chapter 10, Section 8 of the Minneapolis City Charter and Section 24.180 of the Minneapolis Code of Ordinances, to consider approving the resurfacing of the above designated street locations, and to consider the amount proposed to be assessed to each benefited property and the amount to be funded by the City.
