Background Information: The Mayor appoints members of the Minneapolis Workforce Council (MWC), which oversees the operation of the City's employment and training programs. The selections for the appointments are made by the Mayor with recommendations from the Minneapolis Workforce Council Executive Committee and METP staff. Federal requirements state that specific sectors be represented on the council. The table below lists the prospective Minneapolis Workforce Council appointees by Sector represented on the council. All appointees will serve a two-year term from July 1, 2011 to June 30, 2013, except for Charles McIntosh who will be completing the term of Bobbi Cordano, who has resigned from the MWC. Charles McIntosh will be serving the remainder of the term through June 30, 2012.
