

## **BUSINESS LICENSING CONDITIONS**

The undersigned, as President of Sundance Wholesale Imports, Inc., and applicant for a Class E On-Sale Wine with Strong Beer license; a 2 AM license; a Sidewalk Café license; an All Night Special Foods license; and an Amusement Device license to be located at 10 South 5<sup>th</sup> Street, Suite 1, does hereby agree to the following conditions as an express inducement to the Minneapolis City Council to grant the aforementioned pending applications for Bambino's Pizza & Grill:

1. The applicant has read and understands Minneapolis Code of Ordinances, Chapter 360.70, which governs requirements for the All-night Special Foods license, and understands that the City Council may impose additional conditions on the All-night Special Foods license including limiting the hours of operation and requiring security.
2. The applicant agrees that the establishment shall not sell or serve food after 3:00 AM and no person or persons, except employed security, shall be allowed to remain on the premises after 3:15 for any purpose, except that the licensee and his employees may remain to clean, prepare meals, make necessary repairs or other work therein. In addition, all customers shall receive any to-go orders by 3:00 AM., and all off-site deliveries shall be completed by 3:00 AM.
3. Taking into consideration their late night hours and proximity to several nightclubs, the applicant has agreed to provide on-site security as a condition of their All-night Special Foods license. On Thursday, Friday, Saturday and Sunday, security shall be composed of, at a minimum, two armed security agents or two off-duty law enforcement officers, who shall be exclusively employed by Bambino's, and/or mutually employed between Bambino's and one (1) additional on-sale liquor establishment located within the Lumber Exchange building. On Monday, Tuesday, and Wednesday security shall be composed of one armed security agent or one off-duty law enforcement officer, who shall be exclusively employed by Bambino's. The hours of operation that security is required to be present shall be, at a minimum, four hours in duration, and shall cease at 3:30 A.M.
4. If after a reasonable length of time, should the Minneapolis Police Department determine that the number of security agents or police

officers is insufficient to meet security demands, the applicant agrees to comply with Department recommendations for staffing.

5. The applicant agrees that the sidewalk café will not operate after 10:00 PM nightly.
6. All sales of wine and beer are prohibited between the hours of 2:00 AM and 8:00 AM. All unopened alcoholic beverage containers must be secured and made unavailable to patrons between the hours of 2:00 AM and 8:00 AM.
7. No person, including the licensee and his employees and agents, shall consume wine or beer on the premises between 2:30 AM and 8:00 AM. The presence of open alcoholic beverage containers available to patrons on the premises is prima facie evidence of its intended consumption.
