**Subject:** 1. Third Avenue South (Avenue of the Arts) Street Reconstruction Project, Special Improvement of Existing Street Number 6538: Designation, Cost Estimate, List of Benefited Properties, Apply 2002 Uniform Assessment Rates and Set Public Hearings

2. Set Public Hearing for Abandonment and Removal of Areaways in Conflict with Street Reconstruction Project

**Recommendation:** 1(a). Passage of a Resolution designating the location, streets and improvements proposed to be made in the Third Avenue South (Avenue of the Arts) Street Reconstruction Project.

This Resolution may be authorized for summary publication.

1(b). Adoption of a Committee Report receiving the cost estimate of \$9,225,000 and the list of benefited properties, directing the City Engineer to prepare a proposed Street Construction Special Improvement Assessment against the list of benefited properties by applying the 2002 Uniform Assessment Rates and directing the City Clerk to give notice of a Project Approval and Assessment Public Hearing to be held on March 7, 2002 before the Transportation and Public Works Committee.

2. Setting a public hearing to be held on March 7, 2002 before the Transportation and Public Works Committee to consider the abandonment and removal of areaways in conflict with the street construction project and directing staff to give notice in accordance with the provisions of Section 95.90 of the Minneapolis Code of Ordinances.

## **Background/Supporting Information:**

### Third Avenue South Street Reconstruction Project

The purpose of this letter is to designate the location, streets and improvements, establish the special assessment improvement proceedings for street reconstruction.

The location of the street reconstruction project is 3<sup>rd</sup> Avenue South from 12<sup>th</sup> Street South to Washington Avenue. Third Avenue South at this location is Minnesota State Aid Route No. 305.

As provided in Chapter 10, Section 6 of the City Charter, submitted herewith is a list of parcels with owner's names, as nearly as can be readily ascertained, which would be benefited by and assessed for the Third Avenue South Street Reconstruction Project.

Also submitted is a cost estimate of \$9,225,000 for the Third Avenue South Street Reconstruction Project.

The street reconstruction special assessments would be determined by applying the 2002 Uniform Assessment Rates to the land area of benefited parcels located within the street influence zone along the improved street.

### Abandonment and Removal of Conflicting Areaways

Section 95.90 of the Minneapolis Code of Ordinances provides a procedure for dealing with areaway encroachments that would interfere with public improvements being made in the public right-of-way such as street construction. Before the City may abandon and remove conflicting areaways (upon the failure of the abutting property owner to resolve or agree to resolve the conflict) and then later assess the costs, a public hearing must be held. It is our recommendation that this areaway public hearing be held in conjunction with the other Third Avenue South public hearings. Prior to the areaway public hearing notices being given, the City Engineer will have provided the initial notice required in Section 95.90 of the Minneapolis Code of Ordinances.



Third Avenue South from 12<sup>th</sup> Street South to Washington Avenue.

**T&PW** - Your Committee, having received a cost estimate of \$9,225,000 for street reconstruction improvements and a list of benefited properties for the Third Avenue South (Avenue of the Arts) Street Reconstruction Project, Special Improvement of Existing Street Number 6538, as designated by Resolution 2002R-\_\_\_\_\_, passed \_\_\_\_\_, now recommends that the City Engineer be directed to prepare a proposed Street Reconstruction Special Improvement Assessment against the list of benefited properties by applying the 2002 Uniform Assessment Rates as per Resolution 2001R-399 passed September 14, 2001.

Your Committee further recommends that the City Clerk be directed to give notice of a public hearing to be held by the Transportation and Public Works Committee on March 7, 2002, in accordance with Chapter 10, Section 6 of the Minneapolis City Charter and Section 24.180 of the Minneapolis Code of Ordinances, to consider approving the construction of the above designated project and to consider the amount of proposed to be assessed to each benefited property and the amount to be funded by the City.
