Introduction

Several plan documents have been prepared that are related to the proposed Many Rivers Project, including this Modification No. 98 to the Common Plans, Modification No. 7 to the Franklin Avenue Redevelopment Plan, and the Many Rivers West Tax Increment Finance (“TIF”) Plan, (collectively, the “Plans”). Modification No. 7 to the Franklin Avenue Redevelopment Plan authorizes the creation of a new tax increment finance district as a tool for carrying out the redevelopment activities described therein. The Modification also removes parcels from the TIF District No. 27 in order that those parcels can be included in the new Many Rivers West TIF District. Because the Franklin Avenue Redevelopment Project and TIF District No. 27 are in the Common Project, this modification to the Common Project documents is also necessary.

The proposed Many Rivers West Project is located at the northeast corner of E. Franklin Avenue and 14th Avenue S., in Ward 6, Minneapolis, Minnesota.

The site contains tax parcels that are currently within the Franklin Avenue TIF District No. 27, established in 1981. These parcels will be removed from the TIF district and decertified. The Modification to the Franklin Avenue Redevelopment Plan and this Modification No. 98 to the Common Plans document the authorization to decertify the properties from the existing tax increment financing district, which is an incorporated project within the Common Project, and document the authorization to remove the parcels from the TIF district.

The Many Rivers West Project is not feasible within the constraints posed by the existing district because of its short remaining term and the statutory constraints imposed on the use of revenues from pre-1979 TIF districts. Revenue from the existing Franklin Avenue TIF District has been pledged¹ as a potential source of tax increment to service debt on a 1990 revenue bond issue that is insured by the Municipal Bond Investors Assurance (MBIA) Corp. Removal of these parcels from the established TIF District and the creation

¹ On March 15, 2002, several parcels, including parcels that are located within the Many Rivers East TIF District, and those parcels proposed for inclusion in the Many Rivers West TIF District, were released from the prior pledge of TI Revenue Bonds of 1990 (the Common Project) by the MBIA Insurance Corporation.

of the proposed Many Rivers West TIF District received the written consent of the MBIA, releasing these tax parcels from the prior pledge to the 1990 Bonds. The Many Rivers West TIF District is a free standing TIF district, and is not being incorporated into the Common Project. The new project and district will not be subject to the existing Common Project obligations and commitments.

A complete description of the boundary of the Many Rivers West TIF District is found in Section I of the Many Rivers West TIF Plan (under separate cover).

By reference, Modification No. 98 to the Common Plan is incorporated into the Incorporated Project Documents, and in themselves are designated Incorporated Documents.





March 5, 2004**


