Public Hearing Requirement: A public hearing is required for this license application. 51 notices were mailed to residents and property owners within 300 feet of the premises, and emailed to the Downtown Minneapolis Neighborhood Organization and the Warehouse District Business Association on August 1, 2011. The public hearing will be held on August 22, 2011 at the Regulatory, Energy and Environment Committee meeting. As of August 15, 2011, there have been no written responses received for this application.

Background: The applicant proposes to extend the hours of operation for their food manufacturer with delivery service provided by on-site employees from 10:00am to 3:00 am daily.

Findings as Required by the Minneapolis Licensing Code:

The Licenses and Consumer Services Division has analyzed the application and concludes that the application has answered the following:

A security plan that describes the security features, including personnel and equipment, that the applicant will employ and how they will be utilized:

The licensee shall designate an employee as head of the security staff. The designated employee may be the on-site manager. The licensee shall compile, maintain and enforce a "do not admit" list to prevent reoccurrence of disturbances by known persons. This list shall be shared with Minneapolis Regulatory Services and the Minneapolis Police Department upon request. All persons seeking to gain entrance to the establishment after 9:00 p.m. shall be required to present legitimate identification as a condition of entrance. Upon request, the licensee shall meet representatives of the City of Minneapolis to discuss any safety, security or operational concerns. Also, see Domino's corporate security policy.

Description of how the applicant will maintain the orderly appearance and operation of the premises with respect to litter and noise:

Staff will remove litter once daily. The establishment will not tolerate loud employees (in regards to their vehicles or the music from said vehicles) or loud customers.

Description of how the business will have people exit the establishment at closing time and during an emergency that requires all people to exit the establishment quickly:

Because this is a delivery institution, closing time exit is not applicable.

Such other reasonable and pertinent information as the city council may require:

Upon request, the licensee shall meet representatives of the City of Minneapolis to discuss any safety, security or operational concerns.

Proximity to permitted or conditional residential uses.

Nature of the business and its impacts of noise, light and traffic.

There are no residential zones within 500 feet of this establishment.

Conformance with applicable zoning regulations, including but not limited to use, yards, gross floor area and specific development standards.

The existing business is categorized as a food manufacturer which is a permitted use in the Downtown zoning district.

History of complaints related to the use.

There are no significant police calls for service at this exact location. However, this location is in an area where there are significant police calls for service that include call types such as: theft, customer trouble, suspicious person, parking problem, fight, assault in progress, drunk/intoxicated person, robbery of person, unwanted person, miscellaneous. Licenses and Consumer Services records show that there have been no violations related to operating outside the allowed hours of operation. Licenses and Consumer Services has not received complaints regarding noise or unruly customer issues.

RECOMMENDATIONS (pending public hearing):

The Licenses and Consumer Services Division make the following recommendation regarding this application to extend hours:

Grant the license applicant the following Extended Hours:

Sunday - Saturday, from 10:00am to 3:00am daily

This establishment is over 500 feet from a residential district. This is an annually reviewed license. These hours will be reviewed at the next license renewal period. It will be possible to restrict the hours further if there are violations related to the Extended Hours License.
