Council President Barbara Johnson and Members of the City Council,

Upon the request of staff and Council Member Glidden, Chair of the Regulatory, Energy & Environment Committee, I have vetoed the Council action revoking the rental dwelling license held by Abukar Ali Jimale and Abdulaziz Sheikh at 1218 East 26<sup>th</sup> Street. The revocation action was predicated upon several outstanding and unpaid administrative citations, which I have been informed were paid in full shortly after the City Council meeting on August 19, 2011. It has been the practice of staff and the Council to not proceed with license revocation in instances in which all delinquent fines are paid in full prior to the full Council action. Because these license holders paid all outstanding fines on the day of the Council meeting and based on the request of staff I have therefore vetoed the revocation action.
