Background/Supporting Information

On April 1, 2005 the Minneapolis City Council authorized the submission of fourteen applications for projects located in the City of Minneapolis to the Hennepin County 2005 Transit Oriented Development grant solicitation. The Hennepin County Board of Commissioners has approved \$620,000 in funding for seven of these projects located in close proximity to LRT or bus transit stops.

One project approved for funding by Hennepin County was a joint proposal from CPED and Public Works for funds to construct pedestrian lighting near a neighborhood LRT station in order to enhance the safety and comfort of transit patrons and neighborhood residents utilizing transit services and improve the market for nearby transit-oriented development. Hennepin County has awarded \$100,000 to this project for 22 pedestrian lights.

Four of the other projects approved for funding by Hennepin County in 2005 received grants that include funding for a total of 30 pedestrian lights to be installed in the public right-of-way, including Ripley Gardens (6 lights), Little Earth of United Tribes (3 lights), Minneapolis American Indian Center (7 lights), and Village in Phillips Phase II (14 lights).

Hennepin County has proposed to the City of Minneapolis and the four private project applicants that all of the lighting located within the public right-of-way be constructed by the City of Minneapolis in order to insure infrastructure quality, secure economic efficiencies in procurement and construction, and allow for the design and installation of the pedestrian lighting as part of larger transit station pedestrian district improvement projects. Staff from Minneapolis Public Works and Hennepin County Housing, Community Works and Transit has identified a scope of work to

install a total of 52 pedestrian lights to support the five funded projects for the grant amount of \$274,000.

After the Hennepin County TOD grant proposal was submitted, CPED received authorization from the City Council to submit several grant applications to the 2005 Regional TEA-21 funding solicitation to secure additional funding for pedestrian lighting, streetscape, and intersection improvements around the Franklin Avenue LRT Station. To date, these projects have scored well in the competitive project ranking process of the Transportation Advisory Board. Should these TEA-21 projects be funded, the opportunity will exist for CPED and Public Works to coordinate the design and construction of the Hennepin County TOD grant funded improvements with the larger TEA-21 project.

This report requests that the City Council accept the \$274,000 grant from the 2005 Hennepin County TOD program for the installation of pedestrian lights around the transit-oriented development projects and transit stops, appropriate funds, and authorize appropriate City officers to execute the grant agreement. CPED and Public Works will coordinate as necessary the implementation of these projects.
