Subject: **Special Assessment Deferment Applications for street reconstruction and water service line repairs.**

Recommendation:

1. Adoption of a Committee Report approving the special assessment deferment applications submitted by:
 - a. Gail M. Harbeck to defer an existing street reconstruction assessment with a principal balance remaining in the amount of \$3,505.82 for payable 2010 and subsequent years on property at 3921 28th Av S, PID No. 12-028-24-11-0009.
 - b. Barbara Marston to defer a new water service line repair assessment in the principal amount of \$4,180 for payable 2010 and subsequent years on property at 1840 26th St E, PID No. 36-029-24-23-0036.

Financial Impact

Assessment lien against benefited property

Background/Supporting Information:

By the authority of Minnesota Statutes, Sections 435.193 through 435.195 and City Council Resolutions, 80R-365, passed August 8, 1980 and 93R-134 passed April 16, 1993, the City may defer the payment of special assessments for any homestead property owned by a person 65 years of age or older or retired by virtue of a permanent and total disability for whom it would be a hardship to make the payments. During the period of deferment, simple interest will accumulate on the total principal amount of the assessment. The interest rate is the annual average rate of interest earned by the City in previous fiscal years.

In order for Hennepin County to defer the assessment on the tax rolls, a City Council Resolution is required. The Senior Services Ombudsman has reviewed the applicants' qualifications for deferment and is forwarding the following for the Committee's consideration and approval.

- Gail M Harbeck of 3921 28th Ave S, Property ID 12-028-24-11-0009 signed the appropriate papers requesting special assessment deferment for a street reconstruction assessment that was levied to the property taxes starting in 2007 in the original principal amount of \$4,124.48. The assessment now has a remaining balance of \$3,505.82. This deferment would start with the payable 2010 tax year for the street reconstruction assessment.
- Barbara Marston of 1840 26th St E, Property ID 36-029-24-23-0036 signed the appropriate papers requesting special assessment deferment for a water service line repair. The assessment is included on the list of properties for the public hearing that was held on October 20, 2009. The deferment would start with the payable 2010 tax year for the water service line repair assessment.
