WHEREAS, the **Commissioner of Public Safety, Office of Drug Policy and Violence Prevention** ("STATE"), has a grant contract identified as Grant Contract No. 2002-00258 with the **City of Minneapolis, Police Department, 350 S. Fifth Street, Minneapolis, MN 55415** ("GRANTEE"), for the purpose of the racial profiling study, and

WHEREAS, the STATE and the GRANTEE have agreed that additional time is necessary for the satisfactory completion of the grant contract; and

NOW THEREFORE IT IS AGREED BY AND BETWEEN THE PARTIES HERETO:

THAT, Clause IV., of Amendment No. 1 to the original grant contract shall be amended to read:

- IV. **TERM OF GRANT CONTRACT** This grant contract shall be effective on January 1, 2002, or upon the date that the final required signature is obtained by the STATE, pursuant to Minn. Stat. § 16C.05, Subd. 2., whichever occurs later, and shall remain in effect until ~~June 30, 2003~~ **October 31, 2003**, or until all obligations set forth in this grant contract have been satisfactorily fulfilled, whichever occurs first. **The GRANTEE must not begin work under this grant contract until this contract is fully executed and the GRANTEE has been notified by the STATE'S Authorized Representative to begin work.**

By execution of this amendment, the terms and conditions of the original grant contract and all previous amendments are expressly reaffirmed.

Except as herein amended, the provisions of the original grant contract and all previous amendments remain in full force and effect.


