**Recommendation:**

Acceptance of the low bid of Huls Bros. Trucking, Inc. for an estimated annual expenditure of \$600,000.00 to furnish and deliver all labor, materials, equipment and Incidentals necessary to complete the Hauling and Disposal of Treatment Residuals Phase II beginning on or after June 2011 through December 31<sup>st</sup>, 2012 for the Minneapolis Public Works Water Works Division, as follows:

**Base Bid:** Hauling of full trailers from the Dewatering Plant during regular hours, as defined between 6:00 AM to 6 PM on Monday to Saturday of each week per unit price per trailer load \$351.00

**On-Call Bid:** Hauling full trailer loads from the Dewatering Plant during non-regular hours, Sunday or holidays upon request of the City ( the contractor will receive a 24-hour notice if on-call hauling is required; however the City will not pay the on-call bid price if contractor must haul from plant during the outside regular hours in order to comply with requirements of these specifications). per unit price per trailer load \$421.00

Terms are net-30 days F.O.B.: Destination

Further recommend proper Officers be authorized and directed to execute a contract for this service, all in accordance with our specifications.
