Subject: **Correction to amendment of critical traffic and parking area (CPA) # 26 --
Addition of 3800 block of 30th Avenue South**

Recommendation:

Section 1. That Section 478.730 of the above-entitled ordinance be amended by amending Ordinance 2006-Or-075, Critical Parking Area #26, as follows:

No. 3558 - Both sides of 30th Avenue South between 38th and 39th Streets East (Critical Parking Area #26) (No Parking, Except by Permit, ~~Monday-Friday~~ daily, from 9 am to 10 am and 7 pm to 8 pm).

Previous Directives: Council Actions:

- October 14, 2004 for the establishment of a critical traffic and parking area #26.
- August 4, 2004 from the City Clerk which verified that 75% of the residents signed the petition required for CPA # 26.
- June 20, 2006 Amendment of CPA #26, addition of 3800 block of 30th Avenue South

Background/Supporting Information:

The 3800 block of 30th Avenue has been added to CPA # 26 (see attached) due to parking congestion from "park and ride" commuters taking up available on-street parking near the 38th Street LRT station. It had been intended to be enforced on a daily basis. Unfortunately, the June 20, 2006 council action had stated "Monday – Friday". Daily enforcement had been intended similar to the existing CPA #26 and at no time was Monday – Friday enforcement considered.

This erroneous message is found twice in the original Council Action.

It was implied and had been intended that the amended street would be the same as the established zone ("No Parking Except by Permit, Daily, 9am to 10am and 7pm to 8pm"). The accurate days of the week were reflected on the map attached to the original Council Action. The same map is attached to this document.
