Subject: Amendment No. 1 to Contract No.21870 with J. Fletcher Creamer and Son

Inc. for Cleaning and Lining of Cast Iron Water Mains

Recommendation:

a.) Authorize an amendment to the contract with J. Fletcher and Creamer& Son, Inc, increasing the contract price of \$1,447,796.50 by \$383,500 for a new total contract price of \$1,831,296.50 for the addition of 26,000 feet of cast iron water main to be cleaned and lined in 2006. Funds are available within the project budget (2006 Water Distribution Improvement 7400-950-9535-WTR612)

Previous Directives:

• On April 15, 2005, the City Council authorized entering into a contract with J. Fletcher Creamer & Son, Inc. for cleaning and lining of cast iron water mains for an amount not to exceed \$723,898.25 for 2005 with an option to spend the same amount in 2006 for a total not to exceed amount of \$1,447,796.50 for the years 2005 and 2006.

Background/Supporting Information:

The City of Minneapolis Water Distribution Improvement Plan includes monies for cleaning and lining cast iron water mains. At the time the 2006 cleaning and lining budget was being made, we did not know that the Northwest Quadrant of the Lynnhurst Area of Minneapolis was scheduled to be paved in 2006. When we learned in May of 2006 that this area was going to be paved, we decided to add an additional 26,000 feet of water main to the cleaning and lining contract with J. Fletcher Creamer & Son, Inc. pending approval of the increase by the City Council.
