

**SEX OFFENDER INFORMATION FACT SHEET**  
**RISK LEVEL 3 NOTIFICATION**  
**Minneapolis Police Department**

The Minneapolis Police Department is releasing the following information pursuant to Minnesota Statutes 244.052, which authorizes law enforcement agencies to inform the public of a sex offender who has been released from custody regarding his criminal conviction. This disclosure is to inform you that the individual who appears on this notification has been convicted of a sex offense or other offense that requires registration with the local law enforcement agency that has jurisdiction over their residence. This offender has advised the Minneapolis Police Department that he is living in our community and is residing in the area of the **3400 Block Of Logan Avenue North, The Folwell Neighborhood.**

This notification is not intended to increase fear. It is our belief that an informed public is a safer public. The Minneapolis Police Department has no legal authority to direct where a released offender may or may not live. Unless court ordered restrictions exist, an offender may live wherever he chooses.

Sex offenders have always lived in our communities but it was not until passage of the **Community Notification Bill** and **Sex Offender Registration Act**, that law enforcement knew where they were living. Due to the passage of these laws, law enforcement can now share information with the public. Abuse of this information to threaten, intimidate, or harass registered sex offenders will not be tolerated and may be a crime. Such abuse could potentially end our ability to notify the community when sex offenders are released into the public.

The Minneapolis Police Department is available to help you by providing you with useful information on personal safety. The Minneapolis Police SAFE Unit may be contacted at **612-673-5873** to assist you in forming block clubs and receiving information on crime prevention. They will also provide tips to instruct your children on personal safety.

**DESCRIPTION OF OFFENDER:** African American Male, 6'00, 220 Lbs, Medium build, Brown Eyes, Short Black Natural Hair, And Clean Shaven.

**DESCRIPTION OF OFFENSE:** This offender's victim pool are minor aged males. One victim was a runaway and offered a place to stay prior to the offense. In another case, the offender invited several minor aged males to his home, after which he engaged in sexual contact with a 14 year old male. **Photo: 06/20/2012**

**CONDITIONS OF RELEASE: SUPERVISION**

No direct/indirect contact with minors. **Defined as:** Initiating contact.  
Complete sex offender programming. May not solicit contacts using any media.  
May not possess/purchase/view sexually explicit materials in any venue.  
May not reside in a building where children are present.  
May not create/possess modification of allowed images on paper/video/digital.  
May not use the internet for purposes of calling sex/chat/dating/or social lines.  
Must maintain a full time effort of work/education/treatment.  
Comply with Electronic Monitoring/Polygraphs as his agent directs.  
May not own/operate a vehicle without prior agent approval.  
May not enter establishments that provide sexual entertainment.
