

SEX OFFENDER INFORMATION FACT SHEET
RISK LEVEL 3 NOTIFICATION
Minneapolis Police Department

The Minneapolis Police Department is releasing the following information pursuant to Minnesota Statutes 244.052, which authorizes law enforcement agencies to inform the public of a sex offender who has been released from custody regarding his criminal conviction. This disclosure is to inform you that the individual who appears on this notification has been convicted of a sex offense or other offense that requires registration with the local law enforcement agency that has jurisdiction over their residence. This offender has advised the Minneapolis Police Department that he is living in our community and is residing in the area of the **100 Block Of East 38th Street, The Kingfield Neighborhood.**

THIS OFFENDER IS NOT WANTED BY THE POLICE AT THIS TIME.

This notification is not intended to increase fear. It is our belief that an informed public is a safer public. The Minneapolis Police Department has no legal authority to direct where a released offender may or may not live. Unless court ordered restrictions exist, an offender may live wherever he chooses.

Sex offenders have always lived in our communities but it was not until passage of the **Community Notification Bill** and **Sex Offender Registration Act**, that law enforcement knew where they were living. Due to the passage of these laws, law enforcement can now share information with the public. Abuse of this information to threaten, intimidate, or harass registered sex offenders will not be tolerated and may be a crime. Such abuse could potentially end our ability to notify the community when sex offenders are released into the public.

They will also provide tips to instruct your children on personal safety.

THE RELEASED OFFENDER: Terry Darnell Dumas Dob 11/01/58

DESCRIPTION OF OFFENDER: African American Male, 5'9", 188 Lbs, Medium Build, Brown Eyes, Medium Length Black/ Graying Hair, Medium Brown Complexion, With A Long Downward Plunging Mustache. **Vintage Photo: 04/07/2011**

DESCRIPTION OF OFFENSE: This offender, aided by an accomplice, Kidnapped and Sexually Assaulted an adult female in 1993. The victim sustained serious injury and the woman's male companion was robbed and beaten. Neither the victim's ,or suspects were acquainted prior the attacks.

Due to his violating prison rules, supervision failures following release, and on-going substance abuse issues, Mr. Dumas was returned to prison. Following past releases, Mr. Dumas has been mostly " Homeless In Minneapolis." After his most recent incarceration, Mr. Dumas has returned to his former address.

CONDITIONS OF RELEASE: SUPERVISED: UNTIL 04/18/2021

Must successfully complete sex offender programming.

Must not possess in any venue sexually explicit materials ,or enter sexually oriented establishments. Must submit to impromptu polygraphs.

May not use any social networking device/internet without prior approval.

Obtain/maintain full time employment/education or a combination of these.

Must comply with all programming requirements per his agent.

May not own/operate a motor vehicle without prior approval from his agent.

Must submit to checking/financial account monitoring by his agent.
