

**SEX OFFENDER INFORMATION FACT SHEET**  
**RISK LEVEL 3 NOTIFICATION**  
**Minneapolis Police Department**

The Minneapolis Police Department is releasing the following information pursuant to Minnesota Statutes 244.052, which authorizes law enforcement agencies to inform the public of a sex offender who has been released from custody regarding his criminal conviction. This disclosure is to inform you that the individual who appears on this notification has been convicted of a sex offense or other offense that requires registration with the local law enforcement agency that has jurisdiction over their residence. This offender has advised the Minneapolis Police Department that he is living in our community and is residing in the area of the **2000 Block Of Glenwood Avenue North, The Harrison Neighborhood.**

This notification is not intended to increase fear. It is our belief that an informed public is a safer public. The Minneapolis Police Department has no legal authority to direct where a released offender may or may not live. Unless court ordered restrictions exist, an offender may live wherever he chooses.

Sex offenders have always lived in our communities but it was not until passage of the **Community Notification Bill** and **Sex Offender Registration Act**, that law enforcement knew where they were living. Due to the passage of these laws, law enforcement can now share information with the public. Abuse of this information to threaten, intimidate, or harass registered sex offenders will not be tolerated and may be a crime. Such abuse could potentially end our ability to notify the community when sex offenders are released into the public.

The Minneapolis Police Department is available to help you by providing you with useful information on personal safety. The Minneapolis Police SAFE Unit may be contacted at **612-673-2833** to assist you in forming block clubs and receiving information on crime prevention. They will also provide tips to instruct your children on personal safety.

**THE RELEASED OFFENDER: Kirk Douglas Green Dob 12/18/60**

**DESCRIPTION OF OFFENDER: African American Male, 5'8", 233 Lbs, Large Build, Brown Eyes, Short Black Hair, Medium Brown Complexion, And A Mustache**

**DESCRIPTION OF OFFENSE: This offender's victim pool are adult females. In previous cases, he has lured his victims to his apartment by several means, including his offering drugs, or other favors. Once inside he has gained compliance from his victims through physical force. Mr. Green was acquainted with one victim, but not the 2<sup>nd</sup> victim. In 2010 Mr. Green was convicted of a registration violation and revoked for unauthorized use of an internet device.**

**CONDITIONS OF RELEASE: SUPERVISION**

Complete sex offender programs and all required programming.  
Must not possess/purchase/create sexually explicit materials or enter sexually oriented establishments. Must submit to polygraphs as directed by the agent.  
May not enter establishments whose primary business are liquor sales.  
Maintain full time work/education/treatment or a combination of these.  
May not own/operate a device to access any social media w/o prior approval.  
May not own/operate a motor vehicle without prior agent approval.
