

SEX OFFENDER INFORMATION FACT SHEET
RISK LEVEL 3 NOTIFICATION
Minneapolis Police Department

The Minneapolis Police Department is releasing the following information pursuant to Minnesota Statutes 244.052, which authorizes law enforcement agencies to inform the public of a sex offender who has been released from custody regarding his criminal conviction. This disclosure is to inform you that the individual who appears on this notification has been convicted of a sex offense or other offense that requires registration with the local law enforcement agency that has jurisdiction over their residence. This offender has advised the Minneapolis Police Department that he is living in our community and is residing in the area of the **2500 Block Of 16th Avenue South, The Phillips East Neighborhood.**

THIS OFFENDER IS NOT WANTED BY THE POLICE AT THIS TIME.

This notification is not intended to increase fear. It is our belief that an informed public is a safer public. The Minneapolis Police Department has no legal authority to direct where a released offender may or may not live. Unless court ordered restrictions exist, an offender may live wherever he chooses.

Sex offenders have always lived in our communities but it was not until passage of the **Community Notification Bill** and **Sex Offender Registration Act**, that law enforcement knew where they were living. Due to the passage of these laws, law enforcement can now share information with the public. Abuse of this information to threaten, intimidate, or harass registered sex offenders will not be tolerated and may be a crime. Such abuse could potentially end our ability to notify the community when sex offenders are released into the public.

The Minneapolis Police Department is available to help you by providing you with useful information on personal safety. The Minneapolis Police SAFE Unit may be contacted at **612- 673-3482** to assist you in forming block clubs and receiving information on crime prevention. They will also provide tips to instruct your children on personal safety.

DESCRIPTION OF OFFENSE: Mr. Franklin's victim pool are adult females that were strangers at the time of the offense. Physical force and threats were used to gain compliance. Both victim's were approached in public places and engaged in conversation by the offender prior to the attacks. * Mr. Franklin has an extensive criminal history dating back to 1996.

CONDITIONS OF RELEASE: SUPERVISED RELEASE

Successfully complete sex offender, domestic assault and anger management programming. Submit to GPS monitoring and polygraphs as directed.

May not possess/purchase sexually explicit materials in any venue ,or enter sexually oriented business establishments.

May not operate/own an internet device nor access any social media without approval. May not engage in sex/chat/dating/or social lines by internet or other communications. May not create images by paper/video/or digital means.

Comply with alcohol/drug programming as directed.

Obtain/maintain a full time schedule of work/education/treatment.

May not own/operate a motor vehicle without prior approval.
