

SEX OFFENDER INFORMATION FACT SHEET
RISK LEVEL 3 NOTIFICATION
Minneapolis Police Department

The Minneapolis Police Department is releasing the following information pursuant to Minnesota Statutes 244.052, which authorizes law enforcement agencies to inform the public of a sex offender who has been released from custody regarding his criminal conviction. This disclosure is to inform you that the individual who appears on this notification has been convicted of a sex offense or other offense that requires registration with the local law enforcement agency that has jurisdiction over their residence. This offender has advised the Minneapolis Police Department that he is living in our community and is residing in the area of the **1000 Block Of Knox Avenue North, The Near North Neighborhood.**

This notification is not intended to increase fear. It is our belief that an informed public is a safer public. The Minneapolis Police Department has no legal authority to direct where a released offender may or may not live. Unless court ordered restrictions exist, an offender may live wherever he chooses. Sex offenders have always lived in our communities but it was not until passage of the **Community Notification Bill** and **Sex Offender Registration Act**, that law enforcement knew where they were living. Due to the passage of these laws, law enforcement can now share information with the public. Abuse of this information to threaten, intimidate, or harass registered sex offenders will not be tolerated and may be a crime. Such abuse could potentially end our ability to notify the community when sex offenders are released into the public.

They will also provide tips to instruct your children on personal safety.

DESCRIPTION OF OFFENDER: African American Male, 5'08", 305 Lbs, Large Build, Brown Eyes, Medium Brown Complexion, Short Black Natural Hair, With A Mustache And Goatee. Subject Wears Glasses. **Photo: 10/04/2011**

DESCRIPTION OF OFFENSE: Mr. Nick's victim pool have been females aged 11 to adult. In the adult case, (1996) Mr. Nick's and accomplices kidnapped, robbed, and sexually assaulted an adult female stranger and used force to gain compliance. #2 Mr. Nicks fondled his girlfriend's minor aged daughter in a 2001 case. Mr. Nick's is a **lifetime** registrant.

CONDITIONS OF RELEASE: SUPERVISION

Successfully complete sex offender programming.

May not possess sexually explicit material in any venue ,or patronize sexually oriented establishments. Comply with all programming directives.

May not access social media with any device used for this purpose.

Must not enter any establishment that sells alcoholic beverages.

Obtain/maintain a full time schedule. Submit to polygraphs.

May not operate a motor vehicle without agent pre-approval.
