

SEX OFFENDER INFORMATION FACT SHEET
RISK LEVEL 3 NOTIFICATION
Minneapolis Police Department

The Minneapolis Police Department is releasing the following information pursuant to Minnesota Statutes 244.052, which authorizes law enforcement agencies to inform the public of a sex offender who has been released from custody regarding his criminal conviction. This disclosure is to inform you that the individual who appears on this notification has been convicted of a sex offense or other offense that requires registration with the local law enforcement agency that has jurisdiction over their residence. This offender has advised the Minneapolis Police Department that he is living in our community and is residing in the area of the **2900 Block Of 17th Avenue South, The Phillip's East Neighborhood.**

This notification is not intended to increase fear. It is our belief that an informed public is a safer public. The Minneapolis Police Department has no legal authority to direct where a released offender may or may not live. Unless court ordered restrictions exist, an offender may live wherever he chooses.

Sex offenders have always lived in our communities but it was not until passage of the **Community Notification Bill** and **Sex Offender Registration Act**, that law enforcement knew where they were living. Due to the passage of these laws, law enforcement can now share information with the public. Abuse of this information to threaten, intimidate, or harass registered sex offenders will not be tolerated and may be a crime. Such abuse could potentially end our ability to notify the community when sex offenders are released into the public.

The Minneapolis Police Department is available to help you by providing you with useful information on personal safety. The Minneapolis Police SAFE Unit may be contacted at **612-673-3482** to assist you in forming block clubs and receiving information on crime prevention. They will also provide tips to instruct your children on personal safety.

DESCRIPTION OF OFFENDER: African American Male, 5' 11", 157 Lbs , Medium Build, Brown Eyes, Short Black Natural Hair, Dark Brown Complexion, With A Mustache And Short Goatee.

DESCRIPTION OF OFFENSE: In 1987 this offender abducted two adult females. The offender forced sexual contact by using a weapon to gain compliance. Neither victim, or offender were acquainted.

This offender has prior convictions for forgery, burglary and robbery. **Supervision will continue until 01/29/2015. Mr. Leake must register until 06/08/2022.**

CONDITIONS OF RELEASE: SUPERVISION

Successfully complete sex offender programming.

Comply with anger management/domestic assault programming.

May not possess/view sexually explicit materials in any venue ,or establishment.

May not own/operate a vehicle without agent approval.

May not own/operate a computer with internet capability, or call sex/chat/dating

,or social lines. May not possess/create modification of images by paper/digital.

May not use any media for purposes of soliciting personal contact.

Maintain full-time work/education/treatment for a 40 hour week combined.

Must comply with Polygraphs and Electronic Monitoring (GPS) as directed.

Must not act in a financial capacity for another person or business.
