

SEX OFFENDER INFORMATION FACT SHEET
RISK LEVEL 3 NOTIFICATION
Minneapolis Police Department

The Minneapolis Police Department is releasing the following information pursuant to Minnesota Statutes 244.052, which authorizes law enforcement agencies to inform the public of a sex offender who has been released from custody regarding his criminal conviction. This disclosure is to inform you that the individual who appears on this notification has been convicted of a sex offense or other offense that requires registration with the local law enforcement agency that has jurisdiction over their residence. This offender has advised the Minneapolis Police Department that he is living in our community and is residing in the area of the **2600 Block Of Columbus Avenue South, The Phillips West Neighborhood.**

THIS OFFENDER IS NOT WANTED BY THE POLICE AT THIS TIME.

This notification is not intended to increase fear. It is our belief that an informed public is a safer public. The Minneapolis Police Department has no legal authority to direct where a released offender may or may not live. Unless court ordered restrictions exist, an offender may live wherever he chooses.

Sex offenders have always lived in our communities but it was not until passage of the **Community Notification Bill** and **Sex Offender Registration Act**, that law enforcement knew where they were living. Due to the passage of these laws, law enforcement can now share information with the public. Abuse of this information to threaten, intimidate, or harass registered sex offenders will not be tolerated and may be a crime. Such abuse could potentially end our ability to notify the community when sex offenders are released into the public.

The Minneapolis Police Department is available to help you by providing you with useful information on personal safety. They will also provide tips to instruct your children on personal safety.



DESCRIPTION OF OFFENSE: This offender's victim pool are juvenile males and vulnerable adult males. Prior offenses occurred in Minnesota ,South Dakota and Colorado. This offender gained access to his victim's in rest rooms and once in a Detox van. Force and manipulation was used to gain compliance in all previous cases. Mr. Vaughn was unacquainted and acquainted with these victim's.

CONDITIONS OF RELEASE: SUPERVISED: UNTIL 07/07/2014
Must successfully complete sex offender and chemical dependency programming.
Must not possess in any venue sexually explicit materials ,or enter sexually oriented establishments. Must submit to impromptu polygraphs.
May not use any social networking device/internet without prior approval.
Obtain/maintain full time employment/education or a combination of these.
Must comply with GPS tracking as directed by his agent.
May not own/operate a motor vehicle without prior approval from his agent.
May not possess/create prohibited paper/video/digital images.
May not participate in internet sex/chat/dating/or social communication.
