

**SEX OFFENDER INFORMATION FACT SHEET**  
**RISK LEVEL 3 NOTIFICATION**  
**Minneapolis Police Department**

The Minneapolis Police Department is releasing the following information pursuant to Minnesota Statutes 244.052, which authorizes law enforcement agencies to inform the public of a sex offender who has been released from custody regarding his criminal conviction. This disclosure is to inform you that the individual who appears on this notification has been convicted of a sex offense or other offense that requires registration with the local law enforcement agency that has jurisdiction over their residence. This offender has advised the Minneapolis Police Department that he is living in our community and is residing in the area of the **100 Block Of East 38<sup>th</sup> Street, The Kingfield Neighborhood.**

This notification is not intended to increase fear. It is our belief that an informed public is a safer public. The Minneapolis Police Department has no legal authority to direct where a released offender may or may not live. Unless court ordered restrictions exist, an offender may live wherever he chooses.

Sex offenders have always lived in our communities but it was not until passage of the **Community Notification Bill** and **Sex Offender Registration Act**, that law enforcement knew where they were living. Due to the passage of these laws, law enforcement can now share information with the public. Abuse of this information to threaten, intimidate, or harass registered sex offenders will not be tolerated and may be a crime. Such abuse could potentially end our ability to notify the community when sex offenders are released into the public.

The Minneapolis Police Department is available to help you by providing you with useful information on personal safety. They will also provide tips to instruct your children on personal safety.

**DESCRIPTION OF OFFENDER:** African American Male, 5'9", 181 Lbs, Medium Build, Brown eyes, Short Black Natural Hair, Dark Brown Complexion, With A Full Beard And Mustache. **Vintage Photo:** 07/31/2012

**DESCRIPTION OF OFFENSE:** This offender's victim pool include adult females and minor aged females when he was a minor himself. These previous offenses occurred in Indiana circa 1990's. Force/assault and threats were used to gain compliance . Accomplices were used in the previous cases. Mr. Glover has a history of domestic abuse, terroristic threats and weapons violations.

**CONDITIONS OF RELEASE: SUPERVISED: UNTIL 03/07/2014**  
Must successfully complete sex offender and chemical dependency programming.  
Must comply with anger management/domestic assault programming.  
No direct/indirect contact with minors. **Definition:** Cannot initiate the contact.  
Must not enter liquor establishments and must submit to polygraphs.  
Maintain full time work/education/treatment or a combination of these.  
May not own/operate a motor vehicle without prior agent permission.  
Must not own/operate an internet device to access social media.  
Must not possess/ purchase /create sexually explicit materials nor enter sexually oriented establishments.
