

SEX OFFENDER INFORMATION FACT SHEET
RISK LEVEL 3 NOTIFICATION
Minneapolis Police Department

The Minneapolis Police Department is releasing the following information pursuant to Minnesota Statutes 244.052, which authorizes law enforcement agencies to inform the public of a sex offender who has been released from custody regarding his criminal conviction. This disclosure is to inform you that the individual who appears on this notification has been convicted of a sex offense or other offense that requires registration with the local law enforcement agency that has jurisdiction over their residence. This offender has advised the Minneapolis Police Department that he is living in our community and is residing in the area of the **500 Block Of Penn Avenue North, The Harrison Neighborhood.**

THIS OFFENDER IS NOT WANTED BY THE POLICE AT THIS TIME.

This notification is not intended to increase fear. It is our belief that an informed public is a safer public. The Minneapolis Police Department has no legal authority to direct where a released offender may or may not live. Unless court ordered restrictions exist, an offender may live wherever he chooses.

Sex offenders have always lived in our communities but it was not until passage of the **Community Notification Bill** and **Sex Offender Registration Act**, that law enforcement knew where they were living. Due to the passage of these laws, law enforcement can now share information with the public. Abuse of this information to threaten, intimidate, or harass registered sex offenders will not be tolerated and may be a crime. Such abuse could potentially end our ability to notify the community when sex offenders are released into the public.

The Minneapolis Police Department is available to help you by providing you with useful information on personal safety. The Minneapolis Police SAFE Unit may be contacted at **612-673-2833** to assist you in forming block clubs and receiving information on crime prevention. They will also provide tips to instruct your children on personal safety.

DESCRIPTION OF OFFENDER: African American Male, 5'11", 162 Lbs, Medium Build, Brown Eyes, Black Hair (Head Shaved To Scalp), Medium Brown Complexion, With A Connecting Mustache To His Chin. **Vintage Photo: 10/15/12**

DESCRIPTION OF OFFENSE: This offender was socializing with adult female acquaintances. The offender and an accomplice forced the females to disrobe and then forced sexual contact. 3 male companions accompanying the women were also assaulted in this encounter. **All were acquainted.** In another case, this offender (brother-in-law to the victim) took advantage of his niece and made sexual contact with her while she was in a sleeping state.

CONDITIONS OF RELEASE: SUPERVISED RELEASE

No direct/indirect contact with minors. **Defined as :** Initiating Contact
Successfully complete sex offender and chemical dependency programming.
Must not enter establishments that sell alcohol as a primary business.
May not possess/view sexually explicit materials in any venue ,or establishment.
May not own/operate a vehicle without agent approval.,
Maintain full-time work/education/treatment for a 40 hour week combined.
Must comply with Polygraphs and Electronic Monitoring (GPS) if directed.
May not own/operate a device with internet nor access social media without prior approval from his agent.
