

**SEX OFFENDER INFORMATION FACT SHEET**  
**RISK LEVEL 3 NOTIFICATION**  
**Minneapolis Police Department**

The Minneapolis Police Department is releasing the following information pursuant to Minnesota Statutes 244.052, which authorizes law enforcement agencies to inform the public of a sex offender who has been released from custody regarding his criminal conviction. This disclosure is to inform you that the individual who appears on this notification has been convicted of a sex offense or other offense that requires registration with the local law enforcement agency that has jurisdiction over their residence. This offender has advised the Minneapolis Police Department that he is living in our community and is residing in the area of the **1900 Block Of Thomas Avenue North, The Willard-Hay Neighborhood.**

This notification is not intended to increase fear. It is our belief that an informed public is a safer public. The Minneapolis Police Department has no legal authority to direct where a released offender may or may not live. Unless court ordered restrictions exist, an offender may live wherever he chooses.

Sex offenders have always lived in our communities but it was not until passage of the **Community Notification Bill** and **Sex Offender Registration Act**, that law enforcement knew where they were living. Due to the passage of these laws, law enforcement can now share information with the public. Abuse of this information to threaten, intimidate, or harass registered sex offenders will not be tolerated and may be a crime. Such abuse could potentially end our ability to notify the community when sex offenders are released into the public.

The Minneapolis Police Department is available to help you by providing you with useful information on personal safety. The Minneapolis Police SAFE Unit may be contacted at **673-2833** to assist you in forming block clubs and receiving information on crime prevention. They will also provide tips to instruct your children on personal safety.

**DESCRIPTION OF OFFENSE:** This offender's victim pool are adult females. Federal conviction in 1983 for Aggravated Assault/Criminal Sexual Conduct where the victim suffered substantial injury. This was a stranger/victim/stranger/ suspect encounter. There is an extensive previous history of Theft, Burglary, Aggravated Robbery and Assault Of A Police Officer for this same offender.

**CONDITIONS OF RELEASE: FEDERAL SUPERVISION**

Must report routinely to his assigned supervision agent and provide routine reports  
Must work at a lawful occupation and refrain from using prohibited drugs/alcohol.  
May not frequent locations where controlled substances are regularly available.  
May not associate with anyone who engages in criminal activity or convicted felons  
Must provide notice to his agent if there is any contact with law enforcement.  
Agree to permit his agent to visit at any time /anywhere and agree to allow the agent to confiscate any contraband prohibited from possession by the offender.  
As directed, must notify third parties of risks occasioned by the offender's history.
