

SEX OFFENDER INFORMATION FACT SHEET
RISK LEVEL 3 NOTIFICATION
Minneapolis Police Department

The Minneapolis Police Department is releasing the following information pursuant to Minnesota Statutes 244.052, which authorizes law enforcement agencies to inform the public of a sex offender who has been released from custody regarding his criminal conviction. This disclosure is to inform you that the individual who appears on this notification has been convicted of a sex offense or other offense that requires registration with the local law enforcement agency that has jurisdiction over their residence. This offender has advised the Minneapolis Police Department that he is living in our community and is residing in the area of the **900 Block Of East 25th Street, The Phillips Midtown Neighborhood.**

This notification is not intended to increase fear. It is our belief that an informed public is a safer public. The Minneapolis Police Department has no legal authority to direct where a released offender may or may not live. Unless court ordered restrictions exist, an offender may live wherever he chooses.

Sex offenders have always lived in our communities but it was not until passage of the **Community Notification Bill** and **Sex Offender Registration Act**, that law enforcement knew where they were living. Due to the passage of these laws, law enforcement can now share information with the public. Abuse of this information to threaten, intimidate, or harass registered sex offenders will not be tolerated and may be a crime. Such abuse could potentially end our ability to notify the community when sex offenders are released into the public.

The Minneapolis Police Department is available to help you by providing you with useful information on personal safety. The Minneapolis Police SAFE Unit may be contacted at **673-3482** to assist you in forming block clubs and receiving information on crime prevention. They will also provide tips to instruct your children on personal safety.

DESCRIPTION OF OFFENDER: White Male, 5'8", 173 Lbs, Medium Build, Blue Eyes, Sandy Hair (Currently Bald-Head Shaved), Medium Complexion And Clean Shaven. Vintage Photo: **01/31/2013**

DESCRIPTION OF OFFENSE: This offenders victim pool are females aged 3 to 13. The sexual contact was directed at an acquaintance and a relative. Mr. Henry has also been convicted for crimes of Terroristic Threats and Domestic Assault and has a history of chemical abuse. He must register through 07/24/2030. Mr Henry was revoked several times from 2000 to 2010 for Supervision and Conditional Release Violations.

CONDITIONS OF RELEASE: SUPERVISION

No direct/indirect contact with minors. **Defined as:** Initiating contact.
May not purchase/possess ,or create sexually explicit material ,or enter sexually oriented establishments.
May not own/operate any device with internet access ,or access social media.
Obtain/maintain a full time schedule.
Comply with all programming as directed by his agent.
Must submit to random polygraphs as directed by his agent.
May not own/operate a motor vehicle without agent permission.
