

SEX OFFENDER INFORMATION FACT SHEET
RISK LEVEL 3 NOTIFICATION
Minneapolis Police Department

The Minneapolis Police Department is releasing the following information pursuant to Minnesota Statutes 244.052, which authorizes law enforcement agencies to inform the public of a sex offender who has been released from custody regarding his criminal conviction. This disclosure is to inform you that the individual who appears on this notification has been convicted of a sex offense or other offense that requires registration with the local law enforcement agency that has jurisdiction over their residence. This offender has advised the Minneapolis Police Department that he is living in our community and is residing in the area of the **3500 Block Of 1st Avenue South, The Lyndale Neighborhood.**

This notification is not intended to increase fear. It is our belief that an informed public is a safer public. The Minneapolis Police Department has no legal authority to direct where a released offender may or may not live. Unless court ordered restrictions exist, an offender may live wherever he chooses.

Sex offenders have always lived in our communities but it was not until passage of the **Community Notification Bill** and **Sex Offender Registration Act**, that law enforcement knew where they were living. Due to the passage of these laws, law enforcement can now share information with the public. Abuse of this information to threaten, intimidate, or harass registered sex offenders will not be tolerated and may be a crime. Such abuse could potentially end our ability to notify the community when sex offenders are released into the public.

The Minneapolis Police Department is available to help you by providing you with useful information on personal safety. The Minneapolis Police SAFE Unit may be contacted at **612-673-5407** to assist you in forming block clubs and receiving information on crime prevention. They will also provide tips to instruct your children on personal safety.

DESCRIPTION OF OFFENDER: African American Male, 6'1", 215 Lbs, Large Build, Dark Brown Complexion, Brown Eyes, Medium Length Natural Black Hair, With A Goatee And Thin Mustache.

DESCRIPTION OF OFFENSE: This offender's victim pool are males and females aged 9 to 11. In both previous cases the offender was acquainted with his victim's prior to the sexual contact. He used bribery and status as a victim's mother's boyfriend to gain compliance.

CONDITIONS OF RELEASE: SUPERVISION

No direct/indirect contact with minors. **Defined as:** Initiating contact.
May not live within 2 blocks of schools, parks ,or places where children gather without agent approval. Comply with GPS monitoring/polygraphs as directed. Successfully complete sex offender programming and all other programming.
May not possess sexually explicit material in any venue , enter business's that provide entertainment of a sexual nature, or liquor establishments.
May not own/operate a social networking device ,or utilize internet capabilities ,or call sex/chat/dating/,or other social communication links.
May not possess/create/modify images whether on paper/video/or digital.
Obtain/maintain full time employment/education, or a combination of these two.
May not own/operate a motor vehicle without prior agent approval.
