

SEX OFFENDER INFORMATION FACT SHEET
RISK LEVEL 3 NOTIFICATION
Minneapolis Police Department

The Minneapolis Police Department is releasing the following information pursuant to Minnesota Statutes 244.052, which authorizes law enforcement agencies to inform the public of a sex offender who has been released from custody regarding his criminal conviction. This disclosure is to inform you that the individual who appears on this notification has been convicted of a sex offense or other offense that requires registration with the local law enforcement agency that has jurisdiction over their residence. This offender has advised the Minneapolis Police Department that he is living in our community and is residing in the area of the **3500 Block Of 1st Avenue South, The Central Neighborhood.**

THIS OFFENDER IS NOT WANTED BY THE POLICE AT THIS TIME.

This notification is not intended to increase fear. It is our belief that an informed public is a safer public. The Minneapolis Police Department has no legal authority to direct where a released offender may or may not live. Unless court ordered restrictions exist, an offender may live wherever he chooses.

Sex offenders have always lived in our communities but it was not until passage of the **Community Notification Bill** and **Sex Offender Registration Act**, that law enforcement knew where they were living. Due to the passage of these laws, law enforcement can now share information with the public. Abuse of this information to threaten, intimidate, or harass registered sex offenders will not be tolerated and may be a crime. Such abuse could potentially end our ability to notify the community when sex offenders are released into the public.

The Minneapolis Police Department is available to help you by providing you with useful information on personal safety. They will also provide tips to instruct your children on personal safety.

DESCRIPTION OF OFFENDER: African American Male, 6'0", 237 Lbs, Large Build, Brown Eyes, Black Hair (Head Shaved), Medium Brown Complexion And A Thin Mustache. **Vintage Photo:** 12/12/2012

DESCRIPTION OF OFFENSE: Mr. Harris' victim pool are adult females he was acquainted with. In each case (2) 1991/1998 physical force and threats were used to gain compliance. Mr. Harris was revoked in 2010 and 2011 for failure to complete chemical treatment programming, possession of chemicals and failing restructure.

CONDITIONS OF RELEASE: SUPERVISED RELEASE

Complete sex offender and alcohol/drug programming.
May not possess sexually explicit images in any venue ,or enter establishments that provide sexual entertainment as a primary business.
May not own/operate a device with internet capability or call sex/chat/dating/or social lines. Maintain work/education/ treatment as a full time regimen.
Must submit to polygraphs and comply with electronic surveillance (GPS) as directed by his agent.
May not possess/create modified images produced by paper/video/digital.
May not use any media to solicit personal contacts.
May not enter liquor establishments without prior approval.
May not own/operate a motor vehicle without prior agent approval.
