

SEX OFFENDER INFORMATION FACT SHEET
RISK LEVEL 3 NOTIFICATION
Minneapolis Police Department

The Minneapolis Police Department is releasing the following information pursuant to Minnesota Statutes 244.052, which authorizes law enforcement agencies to inform the public of a sex offender who has been released from custody regarding his criminal conviction. This disclosure is to inform you that the individual who appears on this notification has been convicted of a sex offense or other offense that requires registration with the local law enforcement agency that has jurisdiction over their residence. This offender has advised the Minneapolis Police Department that he is living in our community and is residing in the area of the **1000 Block Of Knox Avenue North, The Near North Neighborhood.**

THIS OFFENDER IS NOT WANTED BY THE POLICE AT THIS TIME.

This notification is not intended to increase fear. It is our belief that an informed public is a safer public. The Minneapolis Police Department has no legal authority to direct where a released offender may or may not live. Unless court ordered restrictions exist, an offender may live wherever he chooses.

Sex offenders have always lived in our communities but it was not until passage of the **Community Notification Bill** and **Sex Offender Registration Act**, that law enforcement knew where they were living. Due to the passage of these laws, law enforcement can now share information with the public. Abuse of this information to threaten, intimidate, or harass registered sex offenders will not be tolerated and may be a crime. Such abuse could potentially end our ability to notify the community when sex offenders are released into the public.

The Minneapolis Police Department is available to help you by providing you with useful information on personal safety. The Minneapolis Police SAFE Unit may be contacted at **612-673-2833** to assist you in forming block clubs and receiving information on crime prevention. They will also provide tips to instruct your children on personal safety.

DESCRIPTION OF OFFENDER: African American Male, 5'8", 148 Lbs, Slender Build, Brown Eyes, Black Hair (Head Shaved), Medium Brown Complexion And A Short Chin Whisker Growth. Vintage Photo: **06/19/2013**

DESCRIPTION OF OFFENSE: Mr. Park's victims have been exclusively adult females. His sexual offenses date back to 1987 to the most recent of 1996. Threats of violence and use of force were used in each case to gain compliance. Several victim's were also robbed after being attacked. In most cases with one exception, Mr. Parks was not previously acquainted with these victim's.

CONDITIONS OF RELEASE: SUPERVISED RELEASE

Complete sex offender programming and comply with all polygraph requirements
May not consume alcoholic beverages in primary liquor sale establishments.
May not possess/create modification of allowed images either paper/video/digital
May not possess/view sexually explicit materials in any venue ,or establishment.
May not own/operate a vehicle without prior agent approval.
May not use media to solicit personal contact.
