Our main under-represented group is renters.

We are just completing our Phase II NRP Action Plan, so we are coming out of a two-year period [2009-2010] where we engaged in a great deal of planning. Going forward our planning would involve engaging the neighborhood to create funding priorities for future years of CPP funds.

5. How does your organization provide information to the community? How do you gather information from the community?

We have maintained a "Yahoo Group" for the past 8+ years where contact with the neighborhood was via email notices. In addition, in the past we sent out a quarterly newsletter. These two vehicles are being converted and melded into a more intensive monthly or bi-monthly eNews Letter. We are about to begin using Vertical Response to provide web page like content via email. We will continue to send out notices via USPS though reducing the frequency to 3X per year.

We maintain a web site where information is both presented and solicited from the neighborhood.

This past year we did a mailed survey of the entire neighborhood to assist us with creating our NRP Phase II Action Plan.

6. What festivals and events will your organization host or support in 2011?

Our Annual Meeting will be held in February where the Lynnhurst NRP Phase II Action Plan will be presented.

We hold a Summer Festival each year in August that is both a "fun" event and one where we engage the neighborhood in both educational and environmental issues, among others.

7. What else would you like the Neighborhood and Community Engagement Commission know about your organization?

8. Besides funding, what are some other ways that the NCR and NCEC can help your neighborhood organization?

Consulting on the ways other neighborhoods are using CPP funds. Also, assistance in coordinating efforts between neighborhoods. Adjacent [or non-adjacent] neighborhoods may likely have similar needs and priorities where combining events or educational opportunities would be a win for all.
