Select 2 members, 1 for each of the following Workgroups, to serve as representatives of the NRP Policy Board:

1. Program Guidelines, Funding and Implementation
2. Citywide Community Engagement Policy

Background: The Neighborhood and Community Relations (NCR) department will provide an update to the NRP Policy Board on the Neighborhoods 2020 project. This includes the recent update to the Neighborhoods 2020 Roadmap based upon the public comment period that recently concluded and the presentation to the PECE Committee on Monday, May 14, 2018.

Additionally, the NCR department is requesting the NRP Policy Board select 3 representatives to serve on the 3 workgroups that will convene in June to further develop the details related to Neighborhoods 2020. The following workgroups and memberships are as follows:

Work Group 1: Program Guidelines, Funding and Implementation (15 voting members)

Members: 3 cultural community representatives, 2 NCEC, 1 NRP Policy Board (non-NCEC), 5 neighborhood representatives, 2 undoing racism / equity representatives, 1 Council, 1 Mayor. Subject Matter Experts (Development Finance and Neighborhood Specialist) non-voting

Work Group 2: Governance Advisory Structure for Neighborhood and Community Engagement (16 voting members)

Members: 3 cultural community representatives, 2 NCEC, 2 NRP Policy Board (non-NCEC), 5 neighborhood representatives, 2 undoing racism / equity representatives., 1 Council, 1 Mayor. Subject Matter Experts (City Clerk and NCR) non-voting

Work Group 3: Citywide Community Engagement Policy (15 voting members)

Members: 3 cultural community representatives, 2 NCEC, 1 NRP Policy Board (Non-NCEC), 5 neighborhood representatives, 2 undoing racism / equity representatives. 1 Council, 1 Mayor. 3 Subject Matter Experts (NCR and City Departments as needed) non-voting.

The timeline for the work of the Workgroups will be as follows:

- **May 2018** – Present Work Group overview to City Council and request approval to move forward with applications
- **May 14th to June 4th 2018** – NCR accepts applications for Work Groups
- **June 5th to 11th 2018** –NCR in collaboration with NCEC finalize Work Group Membership
- **Late June 2018 – Late November 2018** – Work Groups meet on a regular basis to finalize recommendations for Neighborhoods 2020
- **October 2018** – Public review and comment on Work Group recommendations
- **November 2018**- Work Group finalizes recommendations
- **December 2018- January 2019** – NCR devises implementation plan based on work group recommendations
- **February 2019** – Council adopts program guidelines, advisory board structure and City policy on community engagement

At the May 15th NRP Policy Board, Council Member Reich and School Board Member Samuels were selected to serve on Work Group 2: Governance Advisory Structure for Neighborhood and Community Engagement.
