Traffic changes coming tomorrow!

The closure of 31st St at Nicollet Ave will start tomorrow morning (May 30th) as scheduled. This is needed for the underground work in the intersection. This complete closure will last no more than 10 working days, other lane closures on 31st St may be needed in addition to the full closure. Additional information will be shared as it's available.

Eastbound Lake St will reopen starting Wednesday May 30th.

Local access to Office Max and Shops and Wells Fargo will continue to be on Nicollet from Lake St. Access to the Wells Fargo drive-thru will still be off 31st St.

Thomas and Sons will continue to do soil correction and grading and base work this week. Next week they expect to put down the first layer of asphalt. Additional information will be shared when it's available.

Minneapolis Water should be completed with their cleaning and lining in the Phase 1 section today. Additional information will be shared as it's available.

CenturyLink should be finishing up their manhole work near 34th St and will be moving on to the manhole near 35th St.
