Dear Property Owner and/or Resident,

The Minneapolis City Council is proposing a street reconstruction project on Hennepin Avenue South between Lake Street West and 36<sup>th</sup> Street West.

The scope of the project will encompass the entire right-of-way and include full removal of the existing street, subgrade correction, new pavement, curb and gutter, driveways, sidewalk as needed, streetscape elements as needed, utility work as needed, pavement markings, signals, and signage. The project limits are shown on the attached map, with construction proposed to begin in 2018.

The Department of Public Works will hold a second informational open house to address any questions that you may have about the Hennepin Avenue South Reconstruction project and seek feedback on the corridor. This meeting is a follow up to the introductory project open house held in January, 2017.

The open house will be held on **Thursday, March 9, 2017 between 6:00-8:00 p.m.** at which time project staff will be on hand to share different concepts for the street, seek feedback on the concepts, and answer questions. Attendees may come and go as they please. The meeting will be located at:
