Summary of Items Discussed

Housekeeping

- Minutes of the February 2, 2006 meeting were approved by the PSC.

Action Items from the last meeting were reviewed. The Park Board task to provide a GIS layer for trees will remain on the list.

Small Group Work on Street Reclassification

Small group discussions were used to discuss in more detail the place types, street types and transit proposals for each of five geographic sectors. The PSC members were asked to distribute themselves into five groups – Downtown, South Sector, Southwest Sector, North Sector, and Northeast Sector. Each small group discussion was facilitated by a member of the consultant team. PTN, Sidewalk Gaps, Bike Gaps, Place Type and Street Type maps by sectors were reviewed by each group. For the Downtown area, maps showing the different intra-downtown transit alternatives were also included in the discussion. Comments/input from each group is listed below briefly –

South Sector

- No changes
- Another way to describe Commuter streets is as regional roads.

- The description of the streets needs to clarify that the design is building to building, not just curb to curb. Use a terminology that is easily understood. For example, use ‘busy’, ‘not busy’, ‘can I park in front of my house?’ to describe rather than technical terms related to capacity.

Southwest Sector

- Blaisdell Ave and 1st Ave S are commuter streets from 28th St to 38th St
- 46th St W and I-35W BRT station?
- Improve pedestrian facilities on Nicollet and Lake St.
- Remove left-turns on Lyndale Ave
- Take into consideration access changes to I-35W on 36th St east of Nicollet
- Midtown greenway
- Show Cedar Lake and France Ave connection
- Show frontage road between Theodore Pkwy and Penn Ave

North Sector

- Show 26th Ave N between Washington Ave and West Broadway Ave as a Neighborhood Connector

Northeast Sector

- The neighborhoods along Marshall Street envision it as a Parkway
- 13th Ave NE between Washington St and Marshall St is an activity center – Needs more pedestrian and bike paths, add streetcar.
- Show 18th Ave NE between Monroe St and Stinson Pkwy as a Neighborhood Connector
- Show Monroe St between Lowry Ave and Broadway St as a Neighborhood Connector
- Show 29th Ave NE between Central Ave and Stinson Blvd as a Neighborhood Connector
- More buses needed for east to west connections – for example, it is very difficult to get from Stinson Pkwy to Lyndale Ave
- Lowry Ave needs more buses
- Need neighborhood circulators
- University area has to be more bike friendly

Downtown

- Not many comments on street types as most streets are activity center streets in downtown
- Should coordinate downtown street type designations with areas outside downtown and address connections
- The two-way vs. one-way street operations analysis may impact decisions on street types
- Most discussion was about intra-downtown transit alternatives. Comments included:
 - o How many peak hour buses will be intercepted for the peak intercept-shuttle alternative and what share of people will walk?
 - o How will transfers for through-trips (for example, to the University) be handled with the peak intercept-shuttle alternative?
 - o How many buses will be on Nicollet Mall for each alternative?

- How likely is it that the buses on Nicollet Mall will actually be hybrid technology for the Hybrid alternative?
- What specific improvements will be made for the Convention Center connection on 13th? Will there be a skyway connection? Will there be a street connection to the skyway? Will this alternative work if the service is not directly in front of the Convention Center?
- Will there be a free fare zone downtown?
- How will parking ramp access/egress be handled on Marquette and 2nd Avenue, particularly if Marquette is a transit-only street?
- Will the bike lanes continue to be on Marquette and 2nd Avenue?
- How will two-way operation on Hennepin or other streets affect decisions on transit operations? How will the transit alternatives impact street operations?
- There needs to be better transit service for the near-downtown neighborhoods.
